Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on July 10, 2017. Your complaint alleged that 11th District Democrats may have violated Chapter 42.17A RCW for failure to timely and accurately report contributions, expenditures, debts, and committee officers.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 22308 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On October 16, 2017, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 22308 was filed in Superior Court in the name of Washington State.
- The Superior Court now has primary jurisdiction over the substance of this complaint, and the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
