Enclosed is a copy of the Public Disclosure Commission's Order Imposing Fine that was entered in the above-referenced case. At the August 23, 2017, Brief Enforcement hearing, the Presiding Officer assessed a total civil penalty of \$250 in accordance with WAC 390-37-143, of which \$50 was suspended.

At the October 26, 2017, public meeting of the Public Disclosure Commission, your request for review was granted, and entire \$250 penalty waived, upon condition that you file the missing F-1 report to certify for calendar year 2016 by December 8, 2017.

ORDER ON RESPONDENT'S
REQUEST FOR REVIEW

This matter came before the Washington State Public Disclosure Commission on October 26, 2017, at the PDC office, Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington. Respondent Jack Bermingham requested review of the Commission Order issued on September 5, 2017 following a Brief Enforcement Hearing (brief adjudicative proceeding) in this matter. The matter was held in accordance with Chapters 34.05 and 42.17A RCW and Chapter 390-37 WAC.

Commissioners present included Anne Levinson, Commission Chair (presiding); Jack Johnson, Commission Vice-Chair; and Commissioners John Bridges, Katrina Asay, and David Ammons. Fox Blackhorn-Delph, PDC Compliance Coordinator, presented the matter on behalf of PDC Staff. Also present were Assistant Attorney General Scott Douglas representing the Commission; PDC Executive Director Peter Lavalley;; Assistant Attorney General Chad Standifer on behalf of PDC Staff; and PDC staff member Jana Greer as recorder of the proceedings. Mr. Berminham did not participate in the proceeding. The proceeding was open to the public and recorded.

1 1. Respondent Jack Bermingham was on medical leave from December 2016 through the
2 time he retired from his position as College President in August, 2017.

3 **III. ORDER**

4 The \$250 civil penalty assessed against Mr. Bermingham is hereby waived on condition
5 that he file the F-1 report for 2016 within 30 days of entry of this order. The Executive Director
6 is authorized to enter this order on behalf of the Commission.
