Dear Shawn Roland:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on June 28, 2017. Your complaint alleged that Jinyoung Englund may have violated RCW 42.17A.320 for failure to identify candidate political party preference on the campaign website.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Jinyoung Englund sponsored political advertising, with sponsor ID that disclosed her Republican party preference as (GOP).
- GOP is listed as an acceptable abbreviation of Republican for Sponsor Identification in guidance issued by the PDC here: <https://www.pdc.wa.gov/learn/publications/candidate-instructions/political-advertising/party-preference>

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
