Documentation on Bob McCoy PDC complaint regarding 7th LD Representative Joel Kretz, and Kretz's failure to accurately, completely, and truthfully file F-1 reports. Failure to adhere to RCW Section 42.17A.700.

Failure to report creditors: Kretz owes more than \$7,800 in past-due taxes to Okanogan County. Kretz has approximately 25 parcels of land, he has been paying his property taxes three (3) years in arrears. The entire list of parcels is available at
