

On April 8, 2017, Respondent Leo A. Perales filed his PDC form C1 for Kennewick City Council, Position 4 (See **EXHIBIT 1**). Respondent Perales filed for Full Reporting. Respondent Perales maintains a mailing address of 1411 W. 16th Avenue, Kennewick, Washington 99337, a telephone number of (509) 551-8496, and an email address of leo4council@gmail.com.

On April 13, 2017, Jim Van Der Heyden registered the website <http://www.leo4kennewickcouncil.com>. The same date, the web hosting site Hostmonster Inc (1958 South 950 East, Provo Utah 84606, Phone: (801) 494-8462) was engaged to provide hosting services for Respondent Perales. The website <http://www.leo4kennewickcouncil.com> serves to advance the campaign of Respondent Perales for Kennewick City Council. Respondent Van Der Heyden maintains an address of 1528 169TH PL SW, Lynnwood Washington 98037, a phone number of (206) 914-9555, and an email address of FASRON101@GMAIL.COM. **EXHIBIT 2** is a copy of the <https://whois.icann.org> report concerning the website's registrant. **EXHIBIT 3** is a copy of the front page of the website.

On May 17, 2017 at 4:23 pm., Leo A. Perales filed for Kennewick City Council, Position 4, See **EXHIBIT 4, page 2**. A primary election will be held August 1, 2017. The General Election will be held November 7, 2017.

The April 13, 2017 website purchase, website design and website hosting was never reported to the PDC as a campaign expense, inkind contribution, nor independent expenditure. In addition, no candidate or campaign organization reported the contributions for the registration of the website <http://www.leo4kennewickcouncil.com/>, development of its website content, nor its hosting. This failure to report electronically by Respondents Perales and Van Der Heyden is a violation of RCW 42.17A.240, RCW 42.17A.245 and WAC 390-16-207.

In addition, the actions enumerated herein are in direct conflict with RCW 42.17A.001 which provides in part:

It is hereby declared by the sovereign people to be the public policy of the state of Washington:

- (1) That political campaign and lobbying contributions and expenditures be fully disclosed to the public and that secrecy is to be avoided.
- (2) That the people have the right to expect from their elected representatives at all levels of government the utmost of integrity, honesty, and fairness in their dealings.
- (3) That the people shall be assured that the private financial dealings of their public officials, and of candidates for those offices, present no conflict of interest between the public trust and private interest.
