Dear Mr. Morgan:

On behalf of the Attorney General's Office, I write to advise you of the completion of this office's initial review and decision on the 21 citizen action notices you filed with this office. In each notice you allege that each entity was an out-of-state political committee that had failed to timely file the C-5 report for contributions they made in 2016 to candidates. You filed the same allegations in complaints to the state Public Disclosure Commission. I understand that the Commission staff has been reviewing these complaints and making determinations as to the filing requirement for each entity. It appears that in many instances, the contribution recipient misidentified the entity as a political committee. Also, at least one of the entities is an in-state political committee and filing reports.

As a result of the Commission staff actions, the Attorney General's Office has decided to forego a judicial enforcement action and leave the matter to the Commission to complete. In the event the Commission refers a matter to this Office from its final review of the complaint, we will review the referral and proceed accordingly. If you have any questions, please let us know.
