Re: Citizen Action Notice

Dear Commissioners:

This letter responds to a Citizen Action Notice dated June 15, 2017 that was transmitted to my client, the Pharmaceutical Research and Manufacturers of America (PhRMA) by the Attorney General of Washington. I understand the Attorney General's office referred this matter to the Public Disclosure Commission for disposition.

The Citizen Action Notice was filed by Glen Morgan, who alleges that the Pharmaceutical Researchers & Manufacturers PAC [sic] made an \$800 political contribution on July 14, 2016 to Jay Inslee's 2016 gubernatorial campaign but did not file a form C-5 disclosure form as required for out-of-state political committees that make contributions to Washington state elections.

Upon review of PhRMA's records, it is clear that the contribution was actually made from PhRMA's operating account, not a PAC account. PhRMA is a trade association that does business in the state of Washington, and is not organized for the purpose of supporting or opposing candidates or ballot propositions in another state. A copy of the check dated July 6, 2016, (which was actually for \$1000) payable to Jay Inslee for Washington is attached; it shows that the check was cut from PhRMA's corporate operating account. Accordingly, this is a permissible corporate contribution, not a contribution by an out-of-state political committee, and no form C-5 or any other reporting by PhRMA was required.

After receiving the Citizen Action Notice, we reviewed the Inslee committee's disclosure reports and discovered that they mistakenly reported receiving the contribution in question from the PhRMA PAC. We contacted the committee and they amended their C-3 report to reflect PhRMA, not the PhRMA PAC, as the accurate contributor. A copy of the amended report is attached, and the PhRMA contributions can be found on the last page of the report. PhRMA was not previously aware that this contribution had been reported inaccurately by the recipient committee.



I trust that this information is sufficient to dismiss the Citizen Action Notice filed by Mr. Morgan, but please do not hesitate to contact me if there is any additional information or clarification PhRMA can provide. In light of the foregoing, I respectfully request that the Public Disclosure Commission, and any other agencies that received this notice, determine that the Pharmaceutical Research and Manufacturers of America, and the Pharmaceutical Research and Manufacturers of America PAC, did not violate any campaign finance disclosure laws contained in RCW 42.17A in connection with this matter.
