Dear Will Hall:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on June 7, 2017. Your complaint alleged that Carolyn Ahlgreen may have violated RCW 42.17A.700 by failing to timely file an F-1 Statement of Personal Financial Affairs.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Candidate Carolyn Ahlgreen is a first-time filer who failed to timely file an F-1 Statement of Personal Financial Affairs.
- Candidate Carolyn Ahlgreen's F-1 Statement of Personal Financial Affairs was received by the PDC on June 12, 2017.

Based on these initial findings, staff has determined that in this instance, failure to timely file an F-1 candidate registration form does not amount to a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing enforcement action in this case.
