COMPLAINT

RE: “Snohomish County GOP Leaders Fund” and “Friends of Nate Nehring”

Numerous violations of: RCW 42.17

The following complaint outlines a coordinated effort by a Political Action Committee and a Candidate Campaign Committee to violate the following campaign disclosure laws:

- Failure to register a PAC within the time mandated by law
 - Failure to disclose PAC donations made to candidates
 - Failure to disclose donations made to said PAC
 - Failure to disclose PAC expenditures
 - A possible effort to coordinate conduit contributions
1. The “Snohomish County GOP Leaders Fund” registered to “Manager” Russell Wiita, Snohomish County Councilman Nate Nehring’s legislative aid.
 2. Mr. Wiita is also listed on the campaign committee for the Snohomish County GOP Leaders Fund.
 4. Billye Brooks-Sebastiani is listed an officer on both committees and is also the treasurer on “Snohomish County GOP Leaders Fund.”
 3. Mr. Wiita and Mrs. Sebastiani directed two \$1,000 contributions to Mr. Nehring in late February of 2017—shortly after Mr. Nehring’s campaign committee was formed.
 4. Mr. Wiita and Mrs. Sebastiani did not file a C1 with the PDC until late April of 2017.
 5. Mr. Wiita and Mrs. Sebastiani selected “full reporting” on the C1 filed in April.
 6. Snohomish County GOP Leaders Fund has made other contributions and financial activity.
 7. As of the date of this complaint, no expense or donation disclosures have been made by the Snohomish County GOP Leaders Fund.
