Subject: Complaint regarding Washington North Idaho District Council of Laborers PAC, PDC Case 19032

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on May 22, 2017. Your complaint alleged that Washington North Idaho District Council of Laborers PAC may have violated RCW 42.17A.235 by failing to accurately or timely file contribution or expenditure reports.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 19032 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On August 14, 2017, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 19032 was filed in Superior Court in the name of Washington State.
- The Superior Court now has primary jurisdiction over the substance of this complaint, and the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
