

To Whom it May Concern --

It has come to my attention that despite the attorney General lawsuit against the Thurston County Democratic Central Committee (Thurston Superior Court #17-2-00972-34), and despite multiple attempts to encourage compliance with the statute through the PDC complaint process, the Thurston County Democratic Central Committee has continued to violated **RCW 42.17A**:

1) Illegal late reporting/deposit of campaign contributions. (Violation of RCW 42.17A.235)

State law requires that candidates submit regular, timely, accurate reports of campaign contributions. State law also requires that candidates timely deposit contributions **within 5 business days** of receipt.

Unfortunately, the Thurston County Democratic Party engaged in late reporting/deposit of campaign contributions in numerous instances.
