Subject: Complaint regarding City of Pasco, PDC Case 18340

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on May 15, 2017. Your complaint alleged that the City of Pasco may have violated RCW 42.17A.570 by failing to timely file the annual treasurer's statement (T-1 form) for calendar years 2007, 2008, 2009, and 2010, 2014, 2015, and 2016.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The City of Paso failed to timely file the required T-1 forms for calendar years 2007, 2008, 2009, 2010, 2014, 2015, and 2016.
- The City of Pasco acknowledged its oversight, and filed their required T-1 forms for 2014, 2015, and 2016.
- The City of Pasco is unable to provide T-1 forms for calendars 2007, 2008, 2009, and 2010 since the previous Treasurer is no is longer holding office.

Based on these initial findings, PDC staff has concluded that a more formal investigation into your complaint or pursuing enforcement action in this instance is not warranted. While the city was untimely in their filings, they have been forthright in acknowledging their oversight and diligently worked with Commission staff to get back into compliance. It does not appear that substantial harm was caused to the public for this lack of disclosure.

PDC staff is reminding the City of Pasco about the importance of the timely and accurate filing of the annual T-1 form.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
