

File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that Teresa Purcell has committed multiple additional violations of RCW 42.17A.

1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, Purcell failed to do this.

According to the PDC, the C4 for the time period of 3/1/2017 to 3/31/2017 was due on 4/10/2016.

Unfortunately, Purcell failed to file this report until 4/27/2017, well past the statutory deadline.

2) Failure to report debt. (Violation of RCW 42.17A.235)

Purcell also failed to report the following expenditure as debt on previous C4s:

MARK PURCELL 3/11/2017 \$500.00 LONGVIEW WA 98632 FINAL UTILITIES/CLEAN UP FEE FOR CAMPAIGN OFFICE

This should have been reported as debt on her 7 day pre-general C4 and all subsequent C4s.

3) Failure to report in-kind contribution/debt for legal fees. (Violation of RCW 42.17A.235)

Teresa Purcell was sued by the Attorney General's in December of 2016 for having committed multiple violations of **RCW 42.17A**. She hired an attorney to fight these charges. Unfortunately, she has failed to report the costs associated with this. Because her committee was sued, she must report this on her C4 expenditure form.

4) Failure to report the addresses of vendors, in-kind contributors, entities who she owes money to. Illegal personal use of campaign funds for personal purposes. (Violation of RCW 42.17A.235, .240, RCW 42.17A.445 see WAC 390-16-041)

The following reports are lacking addresses for vendors, in-kind contributors, and entities who Purcell owes money to:

Lacking address for donation to Go Forth Committee (which is also an illegal expenditure of campaign funds for personal purposes **please treat this as a separate allegation for a unique violation**). Also lacking addresses for MULTIPLE newspapers and radio stations. Purcell must amend these reports to include the addresses immediately.

In light of the fact that Purcell has become well acquainted with Washington State's Campaign finance laws due to her current and ongoing litigation with the Attorney General's office, the PDC should investigate the possibility that Teresa Purcell committed the above violations with wilful maliciousness, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for additional criminal prosecution immediately.
