RE: PDC Complaint Against Teresa Purcell

Dear Mr. Ragins:

I write on behalf of Teresa Purcell in response to the Public Disclosure Commission ("PDC") Complaint and corresponding citizen action notice filed against Ms. Purcell by Glen Morgan on May 2, 2017 ("May 2 Complaint"). This letter constitutes Ms. Purcell's response to the May 2 Complaint.

The May 2 Complaint alleges that Ms. Purcell's C-4 expenditure form for March 2017 was due on April 10, 2016. This cannot be the case, as April 10, 2016 is more than one year *before* March 2017. Ms. Purcell filed a C-4 form in April 2017 in which she accurately reported a single campaign expenditure she made in March 2017, a time period that follows the conclusion of the election Ms. Purcell was contesting. Even if Ms. Purcell filed this report on April 27, 2017, as the May 2 Complaint alleges, there is no public harm caused by any short delay, and any such harm was cured by Ms. Purcell accurately reporting her March 2017 expenditure on her recently filed C-4 form.

The May 2 Complaint alleges that Ms. Purcell failed to timely report a \$500.00 payment to Mark Purcell—which Ms. Purcell reported as an expenditure in April 2017—as debt on "her 7 day pregeneral C4 and all subsequent C4s." Ms. Purcell paid Mark Purcell \$500.00 for damage to her campaign office that Mark Purcell uncovered and reported to Ms. Purcell long after the campaign moved out. Ms. Purcell reported that payment on her March 2017 C-4 form, the first C-4 form she was required to file since winding down her campaign in early-December 2016. See RCW 42.17A.235 (explaining that a candidate is obligated to file a C-4 form only if the candidate "has received a contribution or made an expenditure in the preceding calendar month").

The May 2 Complaint next alleges that Ms. Purcell failed to timely report debt or expenditures for legal fees. RCW 42.17A.235(2) only requires campaigns and political action committees to timely report expenditures; it does not require former candidates to report personal expenses. Ms. Purcell believes her legal fees are a personal expense, and she has treated them as such. Therefore, as far as Ms. Purcell is aware, the statute did not require her to disclose these payments as expenditures on any C-4 forms.

The May 2 Complaint alleges that several of Ms. Purcell's C-4 forms "lack[] complete addresses for expenditures to Melissa Vincent" and the "Go Forth Committee," and urges that "Purcell must amend these reports to include the addresses immediately." Ms. Purcell recently filed amended C-4 forms in which she included complete addresses for expenditures to Melissa Vincent. Those forms are attached here as Exhibit A. The address for Go Fourth Committee is P.O. Box 783, Longview, Washington, 98632.

The May 2 Complaint likewise alleges that Ms. Purcell's C-4 forms lack complete addresses for expenditures associated with "MULTIPLE newspapers and radio stations." Ms. Purcell did not make payments directly to the referenced media outlets. Instead, she paid her vendor, Free Range Productions, which purchased media slots on her behalf. Invoices for the payments Ms. Purcell made to Free Range Productions are attached here as Exhibit B. Ms. Purcell's C-4 form No. 100757483 (attached here as Exhibit C) discloses an address for Free Range Production.

Finally, the May 2 Complaint alleges, without factual or legal basis, that a \$200 payment to the Go Fourth Committee of Longview, Washington was "an illegal expenditure of campaign funds for personal purposes." Ms. Purcell's campaign committee donated \$200 to the Go Fourth Committee in connection with Ms. Purcell's participation in the Longview Fourth of July parade as a political candidate. The May 2 Complaint fails to explain why this payment was illegal. It was not.

Ms. Purcell is eager to resolve these issues amicably, without further legal action. To that end, we are happy to provide the PDC whatever documents the PDC needs to close this case. Please confirm that you received this correspondence, and do not hesitate to reach out to me directly if you have any questions.
