

To Whom it May Concern --

It has come to my attention that Bill Fishburn has committed multiple violations of **RCW 42.17A** in his campaign to become a Port of Olympia Commissioner.

**1) Failure to report all contributions and expenditures made prior to registration on the same day C1 form is submitted. (Violation of RCW 42.17A.235(1))**

Fishburn filed his C1 on April 26th and was legally obligated to file a report of all contributions and expenditures made prior to that date.

We know that he has made expenditure and/or accepted contributions because we can see that Fishburn purchased his website domain on 4/25/2017. (See attached).

Although it would have been legally past the deadline, Fishburn could have still filed his C3s and C4s on any day from the 26th to the 30th. It is unclear what he is trying to hide about who is financing his campaign, but he should submit these forms immediately or face additional penalties from the PDC.

**2) Failure to list EJ Zita as a committee officer. (Violation of RCW 42.17A.205 (2)(c), see WAC 390-05-245.)**

Fishburn failed to list EJ Zita as a committee officer, which is required by **RCW 42.17A.205(2)(c)**.

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee" .

EJ Zita was instrumental in recruiting and grooming Fishburn, and is also actively making strategic decisions for his committee. She is also currently attempting to line up campaign funding for Fishburn by making phone calls to various individuals and political committees.

Fishburn must immediately amend his C1 form to list EJ Zita as an officer of his campaign or face additional penalties from the PDC.

**3) Falsely stating that labor unions, county-wide elected officials, and Mayors are endorsing his campaign. (Violation of RCW 42.17A.335(1)(c))**

State law prohibits candidates from making, either directly or indirectly, a false claim stating or implying the support or endorsement of any person or organization when in fact the candidate does not have such support or endorsement.

As you can see from the attached screenshot of Fishburn's website, he is falsely claiming that he has been endorsed by labor unions, county-wide elected officials, and Mayors. **None of this is true.**

Fishburn does have a handful of endorsements (including the endorsement of his committee officer EJ Zita), but currently, he does not have the endorsement of any labor unions, county-wide elected officials, or Mayors.

Fishburn should immediately edit his website to remove this misinformation, or face additional penalties from the PDC.

The PDC should investigate the possibility that Fishburn committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should immediately refer the case to the Attorney General's office for criminal prosecution.
