Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on May 1, 2017. Your complaint alleged that Cathy Wolfe may have violated RCW 42.17A.700 by failing to timely submit an F-1 Statement of Personal Financial Affairs for calendar year 2016.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Respondent Cathy Wolfe failed to timely file an F-1 for calendar year 2016 by the statutory deadline of April 15, 2017.
- Upon notification of delinquency, Respondent Cathy Wolfe filed an F-1A for calendar year 2016 on May 5, 2017.

Based on these initial findings, staff has determined that in this instance, failure to timely file the annual F-1 statement covering calendar year 2016 does not amount to a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement, action in this case.
