Dear Mr. Blackhorn:

We received your email on April 28, outlining a number of concerns regarding the PDC filings of South King County Working Families PAC and its successor, King County Working Families PAC. We believe that the committee is in substantial compliance with PDC reporting requirements and that Mr. Morgan has deliberately inflated the seriousness of his allegations through unfounded speculation and by ignoring other facts that were clearly at his disposal.

Our response to the nine points raised in his complaint are as follows:

- 1) We were previously made aware of the issue of the mail piece supporting De'Sean Quinn for Mayor of Tukwila. This was the result of a design error on the part of the mail vendor and was address in PDC Complaint No. 1258 in November of 2015. A copy of the letter we received from the PDC, indicating that they will not be taking enforcement of this matter, is attached.
- 2) The committee did not collaborate with any candidates in any of the advertisements, nor did Mr. Morgan provide any specific evidence of collaboration. The Committee filed C6 reports with the PDC and certified under penalty of perjury that the ads were produced independently. A copy of each C6 filing is attached. The committee continues to stand behind these filings.
- 3) We do not believe that any debts were unreported or under-reported with the exception of some minor expenses for administrative expenses that did not relate to political advertising and \$310.05 for voter lists (see item 6 below) . We reported the unpaid value of mail pieces that were in production as of each reporting deadline, but except for direct-mail production, all other expense (e.g. postage, mailing, digital advertising, telephoning) were pre-paid prior to their being presented so were not debts prior to their payment. We did observe that the debt to Project Accounting was not updated on the 7 day pre-General report, nor were C4s filed to accrue additional administrative expenses in months where there was not otherwise \$200 of activity (the threshold for filing a C4 report). We are prepared to amend the 7 day C4 or any other reports upon your request, but given that these expenses have now been fully disclosed it would not seem to further the public interest at this late date.

- 4) We acknowledge that the 10/24/15 payment to Moxie Media failed to disclose Capitol City Press as the sub-vendor and are prepared to amend that report upon your request. The other expenses appear to have properly listed sub-vendors when appropriate, with the possible exception of DSPolitical. They placed digital advertising supporting the various candidates. We have inquired with that vendor to see if they can provide us with the sub-vendor information and have not yet received a response. The website production expenses were done in-house by Moxie Media and the digital advertising expenses paid to Moxie media were for design and placement fees. Chism Strategies is a well know vendor for automated telephoning. We do not believe that we would need to provide sub-vendors for this.

Please note also that the committee made C6 filings with the PDC for each of the expenses. These filings broke out in detail the date made, the date first presented and the amounts allocable to each candidate. A copy of these filings are attached. The committee clearly made no effort to conceal or to under-report its expenditures, but if the PDC would like the committee to amend its C4s to fully conform the disclosures that were previously made on C6 filings, we are prepared to do so.

- 5) Moxie Media obtained the photographs from various publically available sources and reported to us that they did not have sub-vendors for photography.
- 6) In researching this question we discovered that the mailing list was not paid for nor reported by the committee (we had assumed originally that the list was already owned or obtained by the mail vendor). The three lists of totaling 10,356 voters was authorized through SEIU 775's subscription to the Win/Win Network of WA's voter file system. While there was no additional cost to SEIU 775 for this list, the committee will pay \$310.05, to SEIU 775 for these lists. This is the fair market value that Win/Win has assigned to the lists.
- 7) David Rolf was not involved in any spending decisions nor does Mr. Morgan elaborate on his belief that Mr. Rolf was required to be listed as an officer.
- 8) See 7) above.
- 9) Step Forward Washington is a non-profit organization in Seattle involved in issue-advocacy and research and share some donors and governance with SKCWFPAC. They are registered with the WA Dept. of Revenue, file annual form 990s with the IRS and periodically file L6 forms with the PDC. A copy of their DOR business registration is attached. We do not believe that this expenditure was impermissible in any way.


