

# File a Formal Complaint - Glen Morgan

[Glenmorgan89](#) reported 12 hours ago (Mon, 3 Apr at 1:00 AM) via Portal Meta

To Whom it May Concern --

It has come to my attention that Janice Zahn -- a 2017 candidate for Bellevue City Council -- has violated numerous provisions of **RCW 42.17A**.

## **1) Failure to timely file C3 & C4 reports on day C1 is filed. (Violation of RCW 42.17A.235(1))**

State law requires that candidates submit reports containing all contributions received and expenditures made on the same day they submit their statement of registration (C1).

Zahn failed to report the in-kind contribution for her website's domain name by the statutory deadline of 1/6/17, which was the day she filed her C1. Zahn purchased her domain name on 1/3/17, however, it was not reported until 2/10/17, well past the statutory deadline.

Additionally, Zahn failed to report the in-kind contribution of a ticket that she had purchased to go to an event at the Bellevue Chamber of Commerce. She purchased the ticket on 1/4/17, however it wasn't reported until 2/10/17, well past the statutory deadline.

Zahn also failed to timely report a loan that she made to herself 1/4/17 until 2/10/17. This was reported well past the statutory deadline.

Zahn must timely file campaign finance reports in the future, or face possible additional penalties from the PDC.

## **2) Failure to report in-kind contribution of professional photography (Violation of RCW 42.17A.235)**

On her campaign website and Facebook page, we can clearly see that Zahn has clearly purchased professional photography.

Unfortunately, Zahn failed to report the source of the in-kind contribution. You can find examples of this professional photography on her website (attached).

Zahn must update her reports to include the source of this professional photography, or face additional penalties from the PDC or the AGs office.

## **3) Failure to report in-kind contribution of Nationbuilder (Violation of RCW 42.17A.235)**

Zahn's website uses a platform called "Nationbuilder". Oftentimes, this platform also comes with the use of free voter files (see attached pricing sheet).

Zahn must update her reports to include the source of this in-kind contribution of Nationbuilder, or face additional penalties from the PDC or the AGs office.

## **4) Failure to list Christian Sinderman and Katherine Bobman as committee officers. (Violation of RCW 42.17A.205 (2)(c), see WAC 390-05-245)**

Zahn's committee failed to list Christian Sinderman and Katherine Bobman as officers on their C1 form, which is required by **RCW 42.17A.205(2)(c)**. Sinderman makes strategic campaign decisions (and does consulting) for the campaign and Katherine Bobman is the professional fundraiser.

Christian Sinderman and Katherine Bobman should have been listed as committee officers, because they, in conjunction with others, made, directed, or authorized expenditures, strategic or policy decisions on behalf of the committee.

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee."

**5) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C1 form. (Violation of RCW 42.17A.425)**

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

Because Christian Sinderman and Katherine Bobman are officers for the committee – despite not being listed on the form – this is a violation. In their roles as strategic consultant and campaign fundraiser respectively, these two individuals doubtlessly made illegal expenditures for the Committee.

**6) Failure to accurately report debt. (Violation of RCW 42.17A.240)**

Zahn failed to report a debt to NWP Consulting. This group is providing consulting services to Zahn's campaign -- services which Zahn has not reported.

Zahn must report her campaign's debt to NWP Consulting immediately, or face additional penalties from the PDC or AGs office.

**7) Failure to properly break down expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205)**

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with **WAC 390-16-037**, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

The Zahn campaign illegally failed to break down the following expense:

NWP CONSULTING 1/31/2017 \$460.00 SEATTLE WA 98104 OVERNIGHT PRINTING - REMITS

Specifically, this expenditure does not show which vendor actually did the printing of these remits.

Zahn must amend her reports to properly break down these expenditures immediately, or face additional penalties from the PDC or AGs office.

**8) Failure to submit accurate F1. (Violation of RCW 42.17A.700, .710)**

Zahn failed to submit an accurate F1 containing all the information required by state law.

This F1 contains very serious omissions.

Among many other errors, Zahn failed to disclose her job with the Port of Seattle.

Additionally, she failed to disclose her role as Governor of the Eastside Gymnastics Club. (See attached).

Zahn also failed to disclose her ownership of a PERC retirement account, and any real estate owned.

Zahn must amend her F1 reports immediately or face additional penalties from the PDC.

I urge the PDC to investigate these claims immediately.

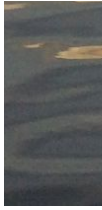

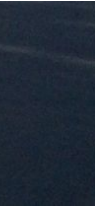

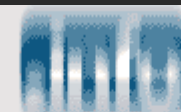
