Each person listed as an endorser of Patrick Monasmith's campaign ad is a witness to the method/manner in which their endorsement was/was not requested. Specifically, James Von Saue let me know directly that he was approached during the day at the Ferry County Superior's Ct house for his endorsement. Michael Clay intimated that he was never asked at all. It is known that Judge Monasmith made visits in person to different departments during the campaign and thus I'm willing to allege the same violation in any/all instances, and would appreciate further investigation by the P.D.C.


