According to the financial rules administered through the Washington State Public Disclosure Commission, the Spokane County Democrats have two types of bank Accounts: Non-exempt and Exempt.

PACS, Unions, Corporations and other entities may contribute up to \$5,000 in a calendar year to the Spokane County Democrats to our **non-exempt account**. The non-exempt funding can be used for everything from operational costs of our organization to campaign activities and campaign contributions.

PACS, Unions, Corporations and other entities can contribute unlimited amounts of money toward our **Exempt Account**. Exempt Accounts cannot use money for direct campaign activity. It can be used for the operations of the organization and organization capacity building. Money in this account supports building the Spokane County Democrats into an efficient professional grassroots political organizing group that can build speak to issues and engage people in every precinct all year long, not just in campaign season.




