Sean Dotson Cheney School District Associate Superintendent does not show up on the Committee for good schools as contributing or loaning the \$2,757.43 for the signs and buttons but only as an expense showing an address of the Cheney School District Office.

I am concerned about where the production of the signs, buttons and phone number acquisitions took place since the address used by the Committee for good school is the District office and Sean Dotson and Vincent Songaylo are District employees.
