I do show both of these gentlemen with the address of the Cheney School District office, but those checks were not mailed to or delivered to that office. By default, I enter the district office address for any CSD employees who contributes money to the Committee through payroll deductions, because I do not get personal addresses for each employee with those contributions. Since both of these gentlemen have contributed through payroll deductions, I have them in ORCA with the district office address, which gets picked up when I input the reimbursement expenditure.

As shown on the invoices for Mr. Dotson, the supplies were delivered to his home, not the district office.
