Dear Ms. Fielding Lopez:

Please consider this a response to the complaint filed by Glen Morgan.

In the initial paragraph of the complaint Mr. Morgan alleges I am Dana Ralph (formerly Dana Stober). I am not nor have I ever been Dana Stober. My maiden name is Kronick and I have used only the name Dana Ralph for the past 26 years. Dana Stober is an entirely different person and I have never even met her. Mr. Morgan also states I am "related to and intimately involved with Bailey Stober". This is also false. I am not related in any way to Bailey Stober nor am I involved with him. It is clear Mr. Morgan has me confused with someone else.

1 – Failure to file report

The \$6,415.00 was reported when the transfer from the 2015 council campaign was made. This transfer of surplus funds from the 2015 council campaign and it is clearly noted this transfer was done with permission of each donor.

I reported the expense of the PO Box on 8/11/16 because that is when it occurred. In a previous complaint Mr. Morgan alleged I did not have a PO Box. I have attached the documentation that this box was used for both the 2015 council campaign as well as the 2017 mayoral race.

2 – Accurate reporting

The C4 for 6/1/16 – 6/31/16 was filed on 7/11/16. 7/10/16 was a Sunday.

3 – Over limit contribution

Both contributions noted were transfers (with permission) from the 2015 council campaign. They were transfers of surplus funds. There is no limit to transfers. There are no funds to return and permission was received from all donors to transfer their contributions.

4 – Debt

The expenditure for the PO Box was made on 8/11/16. There was no debt to report prior to that. The previous year payment on the PO Box was made under the council campaign. The debt was reported when it occurred.

5 – Committee officers

Doug Scharnhorst is clearly listed on the C1 as treasurer of the campaign. Bailey Stober has no involvement with my campaign.

Mr. Morgan has alleged that I am related to Mr. Stober and I am in fact Dana Stober. I did not run for office in 2007 and am not nor have I ever been Dana Stober. The C1 attached to the complaint is not mine. I have not chosen to ignore any requirements.

#### 6 – Expenditure of funds

Bailey Stober does not have authority to spend campaign funds on my behalf. He is not listed as an officer because he is not. He is not my strategic consultant. Doug Scharnhorst is listed as my treasurer on the C1. As treasurer he only makes expenditures with my express permission.

#### 7 – In kind campaign management

I have not failed to report in-kind campaign management. Bailey Stober is not managing my campaign or providing consulting service to me.

#### 8 – Expense description

All expenses are identified. Go Daddy only provides domain registration. USPS is the United States Postal Service. Staples is an office supply store.

#### 9 – Accurate address

This is simply a clerical error which will be addressed.
