

# File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that Nicole Hill (Tumwater City Council) has violated provisions of RCW 42.17A.700, Washington State's campaign finance law.

## **1) Failure to timely file F1 personal financial affairs statement. (Violation of RCW 42.17A.700)**

State law requires that elected officials file their F1 personal financial affairs statement between 1/1 and 4/15 for the preceding calendar year.

Unfortunately, Tumwater City Councilwoman Nicole Hill failed to file her financial affairs statement in a timely fashion. Her F1 for 2015 was not filed until 5/12/2016, which was well past the statutory deadline.

## **2) Failure to accurately disclose ownership of a PERS retirement account as an asset. (Violation of RCW 42.17A.700, see WAC 390-24-010)**

State law requires that elected officials disclose the assets that they own on their F1 statement, if they are over a certain value.

Hill failed to report the value of her PERS retirement account, which is an asset.

The value of Hill's PERS retirement account is almost certainly over \$2400, as she is a longtime public employee in Pierce County.

Hill must be required to amend this form to include accurate information.

## **3) Failure to disclose offices held. (Violation of RCW 42.17A.700, see WAC 390-24-010, 150)**

State law requires that elected officials disclose the offices that they hold on corporations. Nicole Hill is a board member of LOTT, a regional water authority. She is listed as an officer on their corporate form on file with the Secretary of State. (See attached)

Unfortunately, she failed to report this, which is a violation of state law.

## **4) Failure to disclose income from Tumwater City Council. (Violation of RCW 42.17A.700, see WAC 390-24-010)**

State law requires that elected officials disclose the income that they receive in excess of \$2400 from any one source.

Unfortunately, Nicole Hill illegally failed to disclose the income that she received as a member of the Tumwater City Council, approximately \$7920 in 2015, and likely even higher in 2016. (See attachment)

I urge the PDC to investigate these claims immediately. Perhaps some more extensive educational outreach to other government employees who serve in elected office would be helpful to prevent the widespread violation of these laws would be in order. This case could serve as a pretty good example for others to avoid making their own mistakes.
