

## File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that the Thurston County Democrats have committed additional violations of RCW 42.17A.

### **1) Failure to list addresses of expenditure recipients. (Violation of RCW 42.17A.240)**

RCW 42.17A.240 (6) requires that following information is included in C4 expenditure reports:

*"The name and address of each person to whom an expenditure was made in the aggregate amount of more than fifty dollars during the period covered by this report"*

On 2/10/2017, the Thurston County Democrats submitted their C4 covering the month of January.

Unfortunately, the Thurston County Democrats illegally omitted the accurate address of expenditure recipients. Specifically, they failed to provide the addresses for the Department of Revenue and Jessica Blose. They must amend this report immediately to include this information immediately.

### **2) Failure to accurately file expenditure reports (C4) by deadline. (RCW 42.17A.235)**

a) According to the PDC, the accurate report of expenditures (C4) for the time period of 5/1/2016 to 5/31/2016 was due on 6/10/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, Thurston County Democrats' original C4 for this time period (Ref. # 100718174) failed to include an expenditure of \$471 to Meren Gadman for "Kennedy Dinner Accoutrements", an expenditure of \$57 to Century Link for "Phone", an expenditure of \$942.85 to Olympia Copy and Print for "Printing", and an expenditure of \$100 to Port of Olympia for "Booth Space Rental".

The Thurston County Democrats failed to file an accurate report until 2/9/2017, when they submitted an amended C4 that included these expenditures. This is well past the statutory deadline.

b) According to the PDC, the accurate report of expenditures (C4) for the time period of 4/1/2016 to 4/31/2016 was due on 5/11/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, Thurston County Democrats' original C4 for this time period (Ref. # 100692897) failed to include two expenditures valued cumulatively at \$300 to Capitol Lakefair for "deposit", a (second and non-duplicate) expenditure of \$831 to Red Creek Embroidery for "T-Shirts", an expenditure of \$1997 to Tumwater School District for "Black Hills setup", and an expenditure of \$2760 to Tumwater School District for "County Convention".

The Thurston County Democrats failed to file an accurate report until 2/9/2017, when they submitted an amended C4 that included this expenditure. This is well past the statutory deadline.

c) According to the PDC, the accurate report of expenditures (C4) for the time period of 3/1/2016 to 3/31/2016 was due on 4/11/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, Thurston County Democrats' original C4 for this time period (Ref. # 100690742) failed to include an expenditure of \$133 to First Bank Merchant Services, a \$3818 expenditure to Mailbox of Olympia, a \$1626 expenditure to Rivers Edge, a \$335 expenditure to Tumwater School District, a \$535.15 expenditure to Tumwater School District, and another \$335 expenditure Tumwater School District.
