

File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that the Thurston County Democratic Party has violated numerous provisions of RCW 42.17A.

1) Failure to update their C1PC form to include new officers by the statutory deadline. (Violation of RCW 42.17A.205(4))

According to the attached Thurston County Democratic Party's post on Facebook, the following officers were elected on December 12th, with terms that began immediately.

Chair - Katie Nelson
 1st Vice Chair - Jim Reitz
 2nd Vice Chair - Eric Miller
 Secretary - Angie Vega
 Treasurer - Nick Fedaiy
 Committee Woman - Jessica Blose
 Committee Man - Patrick McLaughlin
 Member at Large - Suzanne Kline
 Member at Large - Sarah Boyd

Unfortunately, the Thurston County Democrats failed to file an amended C1PC with their new officers before the 10 day statutory limit expired, putting them in violation of the law.

2) Failure to accurately identify contributors. (Violation of RCW 42.17A.235)

On 5/7/2016, the Thurston County Democrats hosted their annual Kennedy Day Dinner, which is a fundraising event. (See PDC case no. 8928).

According to the PDC, the entire event does not qualify as a low-cost fund raiser (and you must record and report the amounts given by each contributor participating in the event) if the organization: a) sell goods or services at over their fair market value, b) hold food/beverage or entertainment events having an admission price of more than \$25, or c) hold an auction or similar sale and someone donates items worth more than \$50.

In this instance, the Democrats do not qualify for the "low cost fundraiser" exemption, because the per plate price for the dinner was \$65, which is above the statutory limit of \$25. (See attachment of their webpage where they allowed purchase of tickets.)

3) Accepting over-limit contribution from candidate authorized committees, failure to return over-limit contributions within 10 calendar days. (Violation of RCW 42.17A.405, see WAC 390-16-312)

Thurston County Democrats accepted the following illegal donations from candidate authorized non-surplus fund committees: (See PDC case no. 8928, which referenced the Friends of Jim Cooper violation for the Jim Cooper campaign, but did not address this violation for the Thurston County Democratic Party).

Additionally, the Thurston County Democrats failed to return these illegal over-limit contributions within 10 calendar days, which is also a separate and independent violation.

4) Failure to include sponsor ID on TCD website. (Violation of RCW 42.17A.320, see WAC 390-18-010(4))

According to state law, websites must include sponsor ID, specifically a "paid for by" statement, which the Thurston County Democrats fail to do. (See attachment.)

5) Failure to accurately file expenditure and contribution reports (C3s & C4s) by deadline. (Violation of RCW 42.17A.235, .240)

a) According to the PDC, the accurate report of contributions (C3) for the time period of 7/26/2016 to 8/31/2016 was due on 9/26/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all contributions. Namely, their original C3 for this time period (Ref. # 100722345) failed to include the accurate value of the proceeds from a low cost fundraiser, which was actually \$386, instead of the \$1286 that was falsely reported.

They failed to file an accurate report until 11/18/2016, when they submitted an amended C3 that included the accurate level of contributions. This is well past the statutory deadline, and another violation in itself.

b) According to the PDC, the accurate report of expenditures (C4) for the time period of 10/18/2016 to 10/31/2016 was due on 11/01/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, their original C4 for this time period (Ref. # 100731201) failed to include an expenditure to Verizon Wireless for \$86.79, and a donation to Amy Pivetta Hoffman's campaign for \$1000.

c) According to the PDC, the accurate report of expenditures (C4) for the time period of 7/12/2016 to 7/25/2016 was due on 7/26/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, their original C4 for this time period (Ref. #100709934) failed to include the accurate value of expenditures made that are less than \$50. They reported \$19.58 in expenditures that are \$50 or less, when the accurate amount was \$31.59.

d) According to the PDC, the accurate report of expenditures (C4) for the time period of 6/1/2016 to 7/12/2016 was due on 7/13/2016.

Unfortunately, the Thurston County Democrats failed to file an accurate report containing all expenditures. Namely, their original C4 for this time period (Ref. #100706847) failed to include the accurate value of expenditures made that are less than \$50 and failed to include other expenditures. They reported \$92.49 in expenses of \$50 or less, when the accurate number was \$115.05. They also failed to include an expenditure to Mizanur Rahman of \$71.95 for "Misc", an expenditure to Franz of \$151.20 for "buns", a payment to Western Meats of \$967.99 for "meat", a payment to the Olympia School District of \$1303.50 for "room rental for caucus", an expenditure to Tumwater School District of \$1448.13 for "caucus", an expenditure to Century Link of \$50.51 for "phone bill", an expenditure to Olympia Copy and Print of \$72.94 for "misc for meetings", an expenditure to Capital City Pride of \$250 for "burger booth space [sic]", a payment to First Bank Merchant Services of \$176.93 for "fees", and a payment to First Bank Merchant Services of \$1156.91 for "merchant fees -- may [sic]".

They also failed to report an in-kind contribution from Walt Bowen valued at \$1250.00 for "Sound System for Convention".

The accurate report was not filed until 9/2/2016, well past the statutory deadline.

There are many other instances of the Thurston County Democrats failures to abide by the law when it came to timely and accurately filing reports. There were expenditures/debt/ and in-kind contributions for each reporting period in 2016 that were not accurately or timely reported. These violations appear to be habitual, frequent, and commonplace.

6) Multiple violations of RCW 42.17A.240(6) and RCW 42.17A.445.

Please see attached spreadsheet for the specific violations. Thurston County Democrats must update their filings to reflect accurate information.

7) Illegal personal of party funds for drugs. (Violation of RCW 42.17A.445)

On 6/27/2016, the Thurston County Democrats reimbursed Joe Hyer \$241.33 for "spice".

According to Urban Dictionary, "spice" is "...also known as 'synthetic marijuana', 'legal/fake weed', 'K2' etc., is a drug created by spraying herbs with synthetic chemicals that, when consumed, allegedly mimic the effects of cannabis. It's effects are much stronger than those of natural marijuana, and although not thoroughly researched, are known to be dangerous."

This expenditure is entirely illegal, even if the drug itself is legal. Party funds should not be used to fund Hyer's well-documented drug dealing enterprise.

8) Potential failure to include "Sponsor -- JZ Knight/Ramtha" in C1PC name and on all subsequently printed material. (Violation of RCW 42.17A.205, see WAC 390-16-011A(3))

JZ Knight is a politically toxic cult leader who claims to channel a 35,000 year old genocidal Lemurian warrior named "Ramtha". During her rituals, she drinks wine on a stage until she becomes drunk and then rails against Jews, Mexicans, and gays in front of her crowd of followers. She is the well-known leader of a hate cult, according to the Southern Poverty Law Center. She also largely funds the Thurston County Democratic Party and has done so substantially for years.

JZ Knight made a large contribution of \$50,000 to the Thurston County Democrats. According to the reporting of this donation, it was made on 7/7/2016, however, I believe that this contribution was actually made much earlier in the year in the form of a "pledge", as defined under RCW 42.17A.005(13)(a)(i).

Due to this, I believe that the donation from JZ Knight/Ramtha made up more than 80% of the committee's contributions for a substantial portion of the 2016 year.

While the Thurston County Democrats is also a bona-fide political committee, I believe they still fall under the statutory requirements of WAC 390-16-011A(3), and illegally failed to include JZ Knight/Ramtha's name in their committee name and on all subsequently printed materials.

The Commission should clarify as to whether or not bona-fide political parties fall under the statutory requirements of WAC 390-16-011A (3), and whether or not the proper committee name and sponsor ID for electioneering communications should read: "Thurston County Democratic Party -- Sponsored by JZ Knight/Ramtha".

9) Failure to accurately report debt for caucus meeting locations. (Violation of RCW 42.17A.240(8))

The Thurston County Democrats failed to accurately report debt for when they reserved space for their county/LD-level caucuses. Instead, they were reported these expenditures/debts "Teresa Purcell style", i.e. they only reported the expenditure of when they paid the invoice, instead of when they incurred the debt, which was much, much earlier.
