Dear Mr. Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaints you filed on the following dates:

- Case 9044 on 10/19/16 (Complaints 1-3)
- Case 9995 on 11/30/16 (Complaint 4)
- Case 10006 on 11/30/16 (Complaint 5)
- Case 11384 on 12/30/16 (Complaint 7)
- Case 11386 on 12/30/16 (Complaint 8)
- Case 12110 on 1/13/17 (Complaint 9)
- Case 13127 on 2/2/17 (Complaint 6)
- Case 13667 on 2/13/17 (Complaint 10)
- Case 13805 on 2/14/17 (Complaint 11)

Your complaints alleged that People for Thurston County may have violated multiple sections of RCW 42.17A on multiple occasions by failing to properly register and report its contributions and expenditures, failing to include proper sponsor identification in its political advertising, and exceeding contribution limits.

PDC staff suspended its review of your allegations against Respondent People for Thurston County because of the action you took in Thurston County Superior Court under RCW 42.17A.765(4), naming Defendant "People for Thurston County – Thurston-Lewis-Mason Labor Council Sponsor (a political committee), and Jay Manning (Chair)." A Stipulation and Agreed Judgment was accepted in Thurston County Superior Court on August 24, 2017, and filed with the Court on August 28, 2017. The Stipulation and Agreed Judgment included a judgment of \$5,000 with \$4,000 suspended for a period of four years contingent on the named Defendant not being found by the PDC or a court to have committed violations of RCW 42.17A during the period of the suspension. The judgment also included costs and fees of \$7,000 as attorney fees, \$240 as court costs, and \$2,400 as investigation costs.


