Notice of Administrative Charges

I. Jurisdiction

1. The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the Public Disclosure Act; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC. These charges incorporate the Report of Investigation and all related exhibits by reference.

II. Allegations

2. PDC staff alleges that in 2016, Patrick Myers, Publisher of the Willapa Harbor Herald, ran “free” newspaper advertisements in support of Richard Anderson, a candidate seeking election to Pacific County Public Utility District (PUD) Commissioner, District #2, Position No. 3. PDC Staff alleges Mr. Myers violated RCW 42.17A.145 and .255(4) by filing false campaign finance reports disclosing the newspaper advertisements as independent expenditures and electioneering communications made in support of Richard Anderson, when the advertisements were in fact in-kind contributions made in support of Mr. Anderson’s Campaign.

III. Facts

3. On February 16, 2016, Richard E. Anderson filed a Candidate Registration (C-1 report) with the PDC declaring his candidacy for Pacific County PUD Commissioner, District #2, Position No. 3 in 2016.

4. Mr. Anderson was a first-time candidate for public office in 2016, selecting the Mini Reporting option.
5. Mr. Anderson listed Patrick S. Myers as his Campaign Treasurer and only officer. Mr. Myers is also the Publisher of the Willapa Harbor Herald, a local newspaper in Pacific County, and he served in that capacity during the entire time he served as Mr. Anderson's Treasurer.
6. Between May 25 and the August 2, 2016 primary election, the Willapa Harbor Herald sponsored a banner or full-page advertisement in support of Mr. Anderson's candidacy in almost every weekly edition of the Willapa Harbor Herald.
7. While serving as Mr. Anderson's Treasurer, Mr. Myers, as Publisher of the Willapa Harbor Herald, filed a total of 19 C-6 reports disclosing that the Herald ran 19 banner or full-page newspaper advertisements in support of Mr. Anderson totaling \$10,140.
8. Mr. Myers signed each C-6 report declaring, under the penalty of perjury, that each expenditure disclosed in support of Mr. Anderson's campaign was not, "made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate's authorized committee, or an agent of a candidate nor does it otherwise constitute a contribution under RCW 42.17A.005."
9. On September 14, 2016, Mr. Anderson filed an amended C-1 report removing Mr. Myers as the Treasurer for the Anderson campaign.
10. Since Mr. Myers was the Treasurer of Mr. Anderson's Campaign and, at the same time, was authorizing the free newspaper advertisements to run in the Willapa Harbor Herald in support of Mr. Anderson, those advertisements were not independent expenditures or electioneering communications. Rather, the advertisements were reportable in-kind contributions to the Richard Anderson campaign.
11. Regarding the newspaper advertisements that ran in the Willapa Harbor Herald, Mr. Myers stated that he *"created the message, as I knew of Mr. Anderson's positions from attending the meetings."* He also stated that he had *"produced the large ad and it was placed by the production department."*

IV. Laws and Regulations

RCW 42.17A.005(47) states: “‘Treasurer’ and ‘deputy treasurer’ mean the individuals appointed by a candidate or political committee, pursuant to RCW 42.17A.210, to perform the duties specified in that section.”

RCW 42.17A.005(13)(a) states that “‘Contribution’ includes: (i) A loan, gift, deposit, subscription, forgiveness of indebtedness, donation, advance, pledge, payment, transfer of funds between political committees, or anything of value, including personal and professional services for less than full consideration; [and] (ii) An expenditure made by a person in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a political committee, the person or persons named on the candidate's or committee's registration form who direct expenditures on behalf of the candidate or committee, or their agents.”

RCW 42.17A.145 concerns the certification of reports and states: “Every report and statement required to be filed under this chapter shall identify the person preparing it, and shall be certified as complete and correct, both by the person preparing it and by the person on whose behalf it is filed.”

RCW 42.17A.255(4) concerns the reporting of independent expenditures, and states: “All reports filed pursuant to this section shall be certified as correct by the reporting person.”

WAC 390-05-210(3) is entitled “**Consulting with a state, local or judicial candidate**” and states: “An expenditure made by a person in cooperation, consultation, concert or collaboration with, or at the request or suggestion of a candidate, the candidate's authorized committee or agent is a contribution to such candidate. An expenditure is presumed to be made in cooperation, consultation, concert or collaboration with, or at the request or suggestion of a candidate, the candidate's authorized committee or agent when:

...

(c) An expenditure is made by, through, in consultation with, or with the assistance of, including the fund-raising assistance of, any person who, during the twelve months preceding the expenditure, is or has been an officer of the candidate's authorized committee.”

Report of Investigation

I.

Background

- 1.1 On February 16, 2016, Richard E. Anderson electronically filed a Candidate Registration (C-1 report) with the Public Disclosure Commission (PDC) seeking the office of Public Utility District (PUD) Commissioner for Pacific County PUD District #2, Position No. 3 in 2016. **Exhibit #1.**
- 1.2 Mr. Anderson was a first-time candidate for public office in 2016. He selected the Mini Reporting option, and listed Patrick S. Myers as his Campaign Treasurer. Mr. Myers was the only Campaign officer disclosed on the C-1 report, and the report listed the Candidate Committee's Name as "Committee to Elect Responsible PUD Commissioners." (See section 2.26)
- 1.3 Mr. Myers is the Publisher of the Willapa Harbor Herald and the Town Crier, two local newspapers in Pacific County. He is also listed as the Publisher of Traveler's Companion, a SW Washington and Northern Oregon travel publication.
- 1.4 On June 13, 2016, Mr. Anderson filed an amended C-1 report on paper and listed the only change as "None" under the Candidate Committee's Name.
- 1.5 Mr. Anderson also filed a Personal Financial Affairs Statement (F-1 report) for his 2016 candidacy for PUD Commissioner on June 13, 2016. The F-1 report was required to have been filed within two weeks of filing the initial C-1 report, or not later than March 3, 2016. While the F-1 report was filed late by Mr. Anderson, it was filed prior to PDC staff sending out the 2016 candidate F-1 warning letters or hearing notices.

- 1.6 In 2016, there were four candidates seeking election to PUD Commissioner for Pacific County PUD District #2, Position No. 3, including Mr. Anderson. All four candidates — Kenny Ayers, Ron Brummel, Michael Lignoski and Mr. Anderson — selected the Mini Reporting option.
- 1.7 Mr. Anderson received the most votes in a 4-way contested primary election held on August 2, 2016, followed by Mr. Lignoski.
- 1.8 On September 14, 2016, Mr. Anderson electronically filed an amended C-1 report disclosing that Mr. Myers was no longer serving as the Campaign Treasurer, and that Mr. Anderson himself had taken over the duties of the treasurer. **Exhibit #2.**
- 1.9 Mr. Anderson was elected PUD Commissioner on November 8, 2016, receiving 4,854 votes (53.84%) to 4,162 (46.16%) for Mr. Lignoski.

II. Complaint and Allegations

- 2.1 On August 30, 2016, Ron Brummel filed a complaint with the PDC, listing two Respondents and alleging the following (**Exhibit #3**):
 - A. Richard E. Anderson: Mr. Brummel alleged that Richard Anderson exceeded the limitations of the Mini Reporting Option by receiving contributions in the form of free advertising from the Willapa Harbor Herald, a local Pacific County newspaper, that exceeded the \$500 contribution limits from any one contributor. He stated that Mr. Myers served as Mr. Anderson's Treasurer for his campaign, at the same time he was authorizing the advertisements in support of Mr. Anderson to run free of charge, in his role as Publisher of the Willapa Harbor Herald.
 - B. Patrick Myers: Mr. Brummel alleged that Patrick Myers, as Publisher of the Willapa Harbor Herald and as Mr. Anderson's campaign treasurer, authorized newspaper advertisements in support of Mr. Anderson's candidacy, which had been disclosed as Independent Expenditures, but were in fact in-kind contributions to Mr. Anderson's Campaign, thus causing his campaign to exceed the limitations of the Mini Reporting Option.
- 2.2 Mr. Brummel's complaint including the following allegations and documents:
 - The "free advertisements" Mr. Anderson received in the Willapa Harbor Herald as directed by Mr. Myers, as Publisher of the newspaper and Treasurer of the Campaign, were contributions to the Campaign.
 - The advertisements from the Willapa Harbor Herald exceeded the \$500 maximum contribution for a candidate that selected the Mini Reporting option, as well as causing the Anderson Campaign to exceed the \$5,000 in total contributions received limitation of the Mini Reporting Option.

- At the same time the advertisements were running in the newspaper for Mr. Anderson, the Willapa Harbor Herald was charging other 2016 candidate's "the going rate of \$11 per column inch, plus \$160 for a full color charge."
 - Copies of the Willapa Harbor Herald newspaper, which included numerous banner advertisements and at least three full-page advertisements, all in support of Richard Anderson's Campaign for PUD Commissioner.
 - Copies of two Independent Expenditure reports (C-6 reports) filed by Mr. Myers on behalf of the Willapa Harbor Herald.
- 2.3 On September 9, 2016, PDC staff sent letters to Mr. Anderson and Mr. Myers informing them that staff was opening a formal investigation concerning the complaints filed by Mr. Brummel.

III. Executive Summary

- 3.1 Richard Anderson selected the Mini Reporting option for his campaign, and candidates operating under that option are limited to receiving no more than \$5,000 in total contributions and no more than \$500 in the aggregate from any one source. Mr. Anderson listed Patrick S. Myers as his Campaign Treasurer and only campaign officer on his C-1 report.
- 3.2 Mr. Myers is the Publisher of the Willapa Harbor Herald, a local weekly newspaper in Pacific County, and he served in that capacity during the entire time he served as Mr. Anderson's Treasurer. Between May 25 and the August 2, 2016 primary election, the Willapa Harbor Herald sponsored a banner or full-page advertisement in support of Mr. Anderson's candidacy in almost every edition of the Willapa Harbor Herald.
- 3.3 Mr. Myers, as Publisher of the Willapa Harbor Herald, authorized the newspaper advertisements to run in the Willapa Harbor Herald in support of Mr. Anderson and stated that he "*created the message, as I knew of Mr. Anderson's positions*" at the same time he was serving as Treasurer.
- 3.4 While serving as Mr. Anderson's Treasurer, Mr. Myers, as Publisher of the Willapa Harbor Herald, filed a total of 19 C-6 reports disclosing that the Herald ran 19 banner or full-page newspaper advertisements in support of Mr. Anderson totaling \$10,340. **Exhibit #4.** He claimed during the course of the investigation that the advertisements were run "independent" of Mr. Anderson.
- 3.5 Mr. Myers signed each C-6 report declaring, under the penalty of perjury, that each expenditure disclosed in support of Mr. Anderson's campaign was not "made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate's authorized committee, or an agent of a candidate nor does it otherwise constitute a contribution under RCW 42.17A.005."

- 3.6 Since Mr. Myers was Mr. Anderson's Campaign Treasurer, the advertisements that he authorized to run in the Willapa Harbor Herald newspaper were considered in-kind contributions to Mr. Anderson in accordance with WAC 390-05-210(3)(c). The rule states that an expenditure that is "made by, through, in consultation with, or with the assistance of any person who, during the twelve months preceding the expenditure, is or has been an officer of the candidate's authorized committee."
- 3.7 As Treasurer for the Richard Anderson Campaign, Mr. Myers appears to have violated RCW 42.17A.145 by certifying that the C-6 reports he filed on behalf of the Willapa Harbor Herald were independent expenditures or electioneering communications, rather than in-kind contributions.
- 3.8 Mr. Anderson, as candidate, and Mr. Myers as Treasurer, were required to ensure that the Campaign stayed under the thresholds for the Mini Reporting option, which included receiving no more than \$5,000 in total contributions and spending no more than \$5,000 in total, plus the costs of the filing fee, and receiving no more than \$500 in the aggregate of contributions from any one source. Based on the C-6 reports filed by Mr. Myers on behalf of the Willapa Harbor Herald, the \$500 limitation on aggregate contributions from any one contributor was exceeded by Mr. Anderson on June 8, 2016, when the third banner advertisement ran in the Willapa Harbor Herald.
- 3.9 Each banner advertisement cost \$210, bringing the aggregate total to \$630 in advertisements from the Willapa Harbor Herald. Thus, Mr. Anderson was required, by June 8, 2016, to change to the Full Reporting option and meet the requirements thereof, including filing frequent and detailed Monetary Contributions reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contribution and expenditure activities for the remainder of the 2016 election cycle.

IV. Detailed Findings

- 4.1 Candidates appearing on the 2016 primary and general election ballots who selected the Mini Reporting option were limited to the following:
- Receiving no more than \$5,000 in total contributions, plus the costs of the filing fee.
 - Spending no more than \$5,000 in total expenditures made, plus the costs of the filing fee.
 - Receiving no more than \$500 in the aggregate of contributions from any one source.
- 4.2 While serving as Mr. Anderson's Campaign Treasurer, Mr. Myers, as Publisher of the Willapa Harbor Herald (WHH), made the decision to run newspaper advertisements in support of Mr. Anderson. Between May 25 and the August 2, 2016 primary election, a banner or full-page advertisement ran in the Willapa Harbor Herald in support of Mr. Anderson's candidacy every week.

- 4.3 Mr. Myers filed 22 C-6 reports and five amended C-6 reports between July 29 and November 2, 2016, disclosing that WHH made \$10,980 in independent expenditures (IE) or electioneering communications (EC) in support of Richard Anderson's candidacy.
- 4.4 Staff's review of the C-6 reports filed by WHH found that 15 of the C-6 reports were all filed on July 29, 2016, between one and 65 days late, and only four days before the August 2, 2016 primary election. The C-6 reports disclosed the "fair market value" of the banner and full-page advertisements that appeared in the WHH between May 25 and August 3, 2016, in support of Mr. Anderson's candidacy. Of the \$10,980 in IE's or EC's in support of Mr. Anderson for PUD Commissioner, \$7,710 of the IE's or EC's were made prior to the 2016 primary election being held.
- 4.5 After the 2016 primary election, the Willapa Harbor Herald ran six additional banner advertisements and a full-page advertisement in support of Mr. Anderson.

Pat Myers Responses

- 4.6 Pat Myers sent in the following responses to PDC staff:
- On August 30, 2016, Pat Myers sent an email response to the PDC stating that he was treasurer for the 2016 Richard Anderson campaign, and that he is "employed by a newspaper in Pacific County, the WHH." **Exhibit #5.**
 - On May 19, 2017, Mr. Myers submitted a response to PDC staff's follow-up questions and request for additional information. **Exhibit #6.**
 - On July 19, 2017, Mr. Myers submitted an additional response to PDC staff's follow-up questions and request for additional information. **Exhibit #7.**
- 4.7 All three responses from Mr. Myers have been combined into the following response. Mr. Myers stated that WHH endorsed Mr. Anderson for PUD Commissioner prior to the 2016 primary election, and that WHH also ran advertisements in support of Mr. Anderson's campaign.
- 4.8 Mr. Myers stated that prior to running the advertisements, he contacted PDC staff indicating that he was an employee of a newspaper company and that he was also campaign treasurer for a candidate. He informed staff that he did not own the newspaper, and asked if the newspaper would have any limits for a PUD Commissioner candidate and was told no by staff. When asked by staff if he identified himself as Publisher of the WHH during the telephone call, he stated that he did not recall "how" or if he described his position that he held with the WHH when he contacted PDC staff for advice.
- 4.9 Mr. Myers stated that he did not have any conversations or communications with Mr. Anderson about the newspaper advertisements that appeared in the WHH, and that the advertisements were done independently of Mr. Anderson's campaign. He stated that every newspaper advertisement that ran in the WHH in support of Mr. Anderson's candidacy:

“has been registered and reported via the C6 form. I also understand that since Mr. Anderson is uninvolved in this advertising that it is not required to be declared as a campaign contribution, which this advertising is not intended to be.”

- 4.10 Mr. Myers confirmed that he does not own the WHH newspaper, and he stated it is owned by Flannery Properties, a corporation located in Los Angeles, CA. He stated that he attended the Pacific County PUD District #2 Commission meetings as

“an involved citizen of Pacific County. I continue to attend when I can. I did not ever write a news report regarding the PUD. As this utility is part of the democracy that I belong to I am afforded the right to attend commission meetings and every so often be able to add my 2 cents to the discussion.”

He stated that prior to 2016, he had several conversations with Mr. Anderson in which they:

“discussed what we thought was right and wrong about the goings on at the PUD. There were others that I spoke with and whom spoke with me about the same topics during the same timeframe.”

- 4.11 Mr. Myers stated that the WHH services used to produce the Richard Anderson advertisements are also provided by the WHH to all paying advertising customers, and those services are included in the costs. He recalled the Richard Anderson advertisements were produced by the WHH production department, and added that he *“created the message, as I knew of Mr. Anderson’s positions from attending the meetings. I produced the large ad and it was placed by the production department.”*
- 4.12 Mr. Myers stated two of the candidates for Pacific County PUD Commissioner in 2016 ran political advertisements with the WHH, and that the complainant, Mr. Brummel, did not place any advertisements in the WHH (and he added some personal information concerning Mr. Brummel).
- 4.13 Staff questioned Mr. Myers why the WHH ran so many advertisements in support of Mr. Anderson for free during the 2016 election cycle, but apparently none for any other candidates on the 2016 ballot, including other PUD Commissioner candidates. Mr. Myers stated the following:
- “I think that the question ‘why so many’ is subjective. I do not think that it was so many. I made the decision to run ads that favored Mr. Anderson because I liked his positions more than those of the other candidates. Had Mr. Anderson not run I believe that candidate Mike Lignoski would have been the benefactor of those ads because I liked most of his positions as well.”*
- 4.14 Mr. Myers stated that the WHH ran stories on issues that concerned Pacific County, and some of those stories included issues that were being dealt with by the Pacific County PUD.

- 4.15 Mr. Myers stated the WHH was not the only newspaper covering the PUD issues, and that The Chinook Observer, another local newspaper, had reporters in attendance at PUD meetings reporting on those issues. He went on to state the following:

“Some of the issues included the large management salary increases that happened, they gave themselves a 40% raise, the use of and ultimate destruction of a rented piece of equipment by a PUD manager at his home and for personal use, a 15 year old extension project that had never been completed and was costing the citizens 10s of millions, lack of commission oversight, and so on. The newspaper ran those ads because Mr. Anderson was on the right side of those and other issues. The Chinook Observer also came out in favor of Mr. Anderson during this election.”

- 4.16 Mr. Myers was asked if the WHH has run free advertising for any other candidates and to provide any examples of the advertisement, but he did not provide any examples of any other free advertisements that ran in the newspaper solely in support of another candidate.
- 4.17 Mr. Myers stated the WHH printed a two-sided insert for Mike Swanson, an incumbent Pacific County PUD Commissioner who was running for re-election in 2014, that was in support of Mr. Swanson’s candidacy on one side, and an advertisement for Patrizio’s, a local restaurant in the City of Raymond that serves pizza, pasta and burgers. The flyer was an insert and not a newspaper advertisement. (See section 4.28 of this Report of Investigation).

Richard Anderson Response

- 4.18 On May 30, 2017, Mr. Anderson sent a response letter to the PDC, providing additional information to the initial response provided by Pat Myers. **Exhibit #8.** Mr. Anderson stated that he decided to run for PUD Commissioner in April of 2016 (although the C-1 report was filed on February 16, 2016).
- 4.19 Mr. Anderson stated to the best of his recollection, he has known Pat Myers since 1994, and that he asked Mr. Myers to serve as his Campaign Treasurer prior to declaring his candidacy for office. He stated that he and Mr. Myers met to set up his campaign bank account and to review/complete the online PDC filing requirements for PDC reports. He stated that, other than the initial meeting with Mr. Myers, the two rarely met concerning the Campaign. He stated that he received the monetary contributions and deposited them into the Campaign bank account.
- 4.20 Mr. Anderson stated that he made the expenditures to the Campaign vendors and he also picked up the goods and services, such as yard signs he purchased, and he placed all the orders. Staff asked Mr. Anderson to summarize his campaign’s contribution and expenditure activities under the Mini Reporting Option, and he stated the following:
- **Monetary Contributions:** Mr. Anderson stated that the Campaign received two \$500 monetary contributions under the Mini Reporting Option, which is the maximum amount allowed, and included a \$500 monetary contribution from the IBEW Union and a \$500 monetary contribution from Dick Sheldon.

- **Campaign Expenditures:** Mr. Anderson stated that the Campaign made two large expenditures under the Mini Reporting option that included (1) a \$1,345 expenditure to the Chinook Observer, a local newspaper for newspaper political advertising; and (2) a \$1,950 expenditure to purchase campaign yard signs.

- 4.21 Mr. Anderson stated that he does not subscribe to the WHH and was unaware that the advertisements were being run in support of his candidacy "...until after they appeared in the newspaper."
- 4.22 Mr. Anderson stated that he did not have any conversations with Mr. Myers in advance of the advertisements appearing in the WHH that supported his candidacy. He stated he knew Mr. Myers was the Publisher of the WHH, and added that at some point, he thanked Mr. Myers for the advertisements that ran in the newspaper, but he did not identify the date when that conversation occurred.

C-6 Reports filed by Willapa Harbor Herald

- 4.23 As previously noted, between May 25 and the August 2, 2016 primary election, the WHH sponsored a banner or full-page advertisement in support of Mr. Anderson's candidacy in almost every weekly edition of the WHH, during which time Mr. Myers served as Mr. Anderson's Treasurer.
- 4.24 Mr. Myers, on behalf of the WHH, filed all 22 C-6 reports and five amended C-6 reports between July 29 and November 2, 2016, reports disclosing \$10,980 in independent expenditures (IE) or electioneering communications (EC) in support of Richard Anderson's candidacy. The chart below (sec. 4.26) details the IE's of more than \$100; the IE Political Advertisements of more than \$1,000; and electioneering communications (EC) or more than \$1,000 that were disclosed on the C-6 reports filed by Mr. Myers on behalf of the WHH for the newspaper advertisements that supported Mr. Anderson's candidacy. The chart is separated into two sections for the C-6 reports filed by WHH: late filed C-6 reports and timely filed C-6 reports.
- 4.25 The C-6 reporting requirements for IE's and EC's undertaken by WHH during the 2016 election cycle was as follows:
- **Initial C-6 report due May 30, 2016 (IE more than \$100):** The initial C-6 report for an independent expenditure of \$100 or more (box 1 of the C-6 report), was required to have been filed by WHH within five business days of making an independent expenditure.
 - **June 2016 C-6 report due July 10, 2016 (IE more than \$100):** The next required C-6 report for an independent expenditure of \$100 or more (box 1 of the C-6 report), is based on the due date for the next Summary Full Campaign Contributions and Expenditures report (C-4 report), which was required to have been filed by WHH no later than July 10, 2017, disclosing IE's undertaken during June of 2016.

- **C-6 report within 24 hours of making EC:** Between July 1 through August 3, 2016, a C-6 report was required to have been filed by WHH within 24 hours of making an EC (box 3 of the C-6 report), in support of Mr. Anderson since the \$1,000 threshold in aggregate prior IE's had been exceeded.

4.26 The C-6 reports disclosed the following:

4.27 As noted in the chart above:

- WHH failed to timely file the C-6 reports received on July 29, 2016.

- The late filed C-6 reports were received by the PDC between one and 65 days late, and four days before the August 2, 2016 primary election, disclosing \$7,920 for the banner and full-page advertisements that appeared in the WHH in support of Mr. Anderson.
- While serving as Mr. Anderson's Treasurer, Mr. Myers, as Publisher of the WHH, filed a total of 19 C-6 reports disclosing that the Herald ran 19 banner or full-page newspaper advertisements in support of Mr. Anderson, totaling \$10,350.
- WHH ran three additional banner advertisements in support of Mr. Anderson totaling \$630 after September 14, 2016, when Mr. Anderson filed an amended C-1 report removing Mr. Myers as Treasurer.

2014 Election Issue:

- 4.28 After the 2014 general election had been held, PDC staff received an inquiry concerning a flyer sponsored by "Rate Payers Who Support Responsible Commissioners", a portion of which supported a 2014 candidate for PUD Commissioner. The insert in the WHH and previously referenced in section 4.16 of this report of investigation, was inserted and distributed in the Willapa Harbor Herald prior to the 2014 general election being held. The inquiry expressed concerns about the true sponsors of the advertisement, since he had checked the PDC website and there was no political committee registered with the PDC under the name "Rate Payers Who Support Responsible Commissioners."¹
- 4.29 Staff reviewed the insert, in which one side of the two-page flyer supported the re-election of Mike Swanson for Pacific County PUD District #2 Commissioner, and the side of the flyer was an advertisement for Patrizio's, a local Pacific County restaurant. **Exhibit #9.**
- 4.30 The restaurant portion of the insert contained 12 coupons for discounted items or specials.
- 4.31 The other half of the flyer included the information about Mike Swanson's candidacy, and included two statements in large bolded font stating "**Re-Elect Mike Swanson for Commissioner**" and "**Keep the Public in P.U.D.**" and information concerning Mr. Swanson's service as PUD Commissioner and his work on several local boards and foundations. The flyer contained two quotes attributable to Mike Swanson, stating: "*My desire is to continue listening to and serving the customer/owners of the PUD.*" and "*I will continue to utilize information, education and experience along with public input in order to represent the ratepayers.*" Finally, the flyer included one large box with a check mark after Mike Swanson's name, and 10 boxes with check marks after Mike Swanson's name, five across the top of the flyer and five at the bottom of the flyer.

¹ When Richard Anderson filed his initial C-1 report declaring his 2016 candidacy for PUD Commissioner, he listed "Rate Payers Who Support Responsible Commissioners" under the Candidate Committee name.

- 4.32 PDC staff contacted Mr. Swanson and he confirmed that Pat Myers was one of the sponsors of the flyer that was distributed as part of an insert in the Willapa Harbor Herald in support of his candidacy. He indicated that he did not plan, coordinate, or pay for the insert or the portion of the insert that supported his candidacy.
- 4.33 PDC staff contacted Mr. Myers and asked him several questions about the insert to determine whether the advertisement in support of Mr. Swanson's candidacy was required to have been reported as an Independent Expenditure, and whether the insert complied with the Sponsor Identification requirements for political advertising. Mr. Myers stated that "Rate Payers Who Support Responsible Commissioners" consisted of two people: Richard Anderson and himself.
- 4.34 Mr. Myers stated "*We have worked together along with others to try to persuade our PUD commission to be more transparent to the ratepayers of this county. I was not aware that I had to individually list our names. This was not an attempt to hide as I/we have been very vocal, both by way of the newspaper and at the commission meetings and so had no reason or desire to be anonymous. Therefore, my reason for using this name is because there are two of us and we are rate payers who support responsible commissioners.*"
- 4.35 Mr. Myers stated that the total costs for the 4,400 inserts was \$845.60. He stated that Mr. Swanson's portion of the inserts costs were \$422.80, that included \$75 for design and prep; \$167.40 for printing; and \$180.40 to insert and mail.
- 4.36 PDC staff determined that the flyer was an in-kind contribution to the Mike Swanson campaign that failed to include any sponsor identification. PDC staff notified Mr. Myers by email that staff did not intend to pursue enforcement action concerning the lack of proper sponsor identification on the flyer. **Exhibit #10**. However, staff reminded Mr. Myers to ensure that any future political advertising that he is involved with includes a proper sponsor identification, and warned him that his failure to do so could result in enforcement action.

V. Scope

- 5.1 PDC staff reviewed the following documents:
- The complaint and exhibits filed on August 30, 2016, by Ronald Brummel against Richard Anderson and Patrick Myers.
 - Communications between Richard Anderson and PDC Staff.
 - Email communications between Patrick Myers and PDC staff.
 - C-6 reports filed by the Willapa Harbor Herald.
 - C-1 and F-1 reports filed by Richard Anderson.

VI. Statutes and Rules

- 6.1 **RCW 42.17A.005(19)(a)** defines "Electioneering Communication" as any broadcast advertisement, US Postal Service mailing, billboard or newspaper advertisement that clearly identifies a candidate for a state, local, or judicial office by naming the candidate, or identifying the candidate without using the candidate's name. An Electioneering Communication is broadcast, transmitted, mailed, or published within 60 days before any election, alone, or in combination with one or more similar communications made by the same sponsor, has a fair market value of \$1,000 or more.
- 6.2 **RCW 42.17A.005(26)** states "Independent expenditure" means an expenditure that has each of the following elements: (a) It is made in support of or in opposition to a candidate for office by a person who is not (i) a candidate for that office, (ii) an authorized committee of that candidate for that office, (iii) a person who has received the candidate's encouragement or approval to make the expenditure, if the expenditure pays in whole or in part for political advertising supporting that candidate or promoting the defeat of any other candidate or candidates for that office, or (iv) a person with whom the candidate has collaborated for the purpose of making the expenditure, if the expenditure pays in whole or in part for political advertising supporting that candidate or promoting the defeat of any other candidate or candidates for that office;
- 6.3 **RCW 42.17A.005(47)** states "'Treasurer" and "deputy treasurer" mean the individuals appointed by a candidate or political committee, pursuant to RCW 42.17A.210 to perform the duties specified in that section."
- 6.4 **RCW 42.17A.145** concerns the certification of reports and states: "Every report and statement required to be filed under this chapter shall identify the person preparing it, and shall be certified as complete and correct, both by the person preparing it and by the person on whose behalf it is filed."
- 6.5 **RCW 42.17A.255(4)** concerns the reporting of independent expenditures, and states: "All reports filed pursuant to this section shall be certified as correct by the reporting person."
- 6.6 **WAC 390-05-210(3)** is entitled "**Consulting with a state, local or judicial candidate**" and states the following:
- "An expenditure made by a person in cooperation, consultation, concert or collaboration with, or at the request or suggestion of a candidate, the candidate's authorized committee or agent is a contribution to such candidate.
- (3) An expenditure is presumed to be made in cooperation, consultation, concert or collaboration with, or at the request or suggestion of a candidate, the candidate's authorized committee or agent when:
- (c) An expenditure is made by, through, in consultation with, or with the assistance of, including the fund-raising assistance of, any person who, during the twelve months preceding the expenditure, is or has been an officer of the candidate's authorized committee."

6.7 **WAC 390-16-105** states in part the following concerning the eligibility requirements of the Mini Reporting Option:

“(1) A candidate or candidate's authorized committee, as those terms are defined in RCW 42.17A.005, is not required to comply with the provisions of RCW 42.17A.225 through 42.17A.240 except as otherwise prescribed in WAC 390-16-038, 390-16-115, and 390-16-125 when both of the following conditions are present:

(a) Neither aggregate contributions nor aggregate expenditures exceed the amount of the candidate's filing fee provided by law plus a sum not to exceed five thousand dollars; and

(b) No contribution or contributions from any person other than the candidate exceed five hundred dollars in the aggregate. However, a bona fide political party may pay the candidate's filing fee provided by law without that payment disqualifying that candidate from eligibility under this section.”


6.8 **WAC 390-16-105(5)** states in part the following concerning a filer that exceeds the limitation of the Mini Reporting Option: “Exceeding the aggregate contributions or aggregate expenditures specified in WAC 390-16-105 without complying with the provisions of this section constitutes one or more violations of chapter 42.17A RCW or 390-17 WAC.”

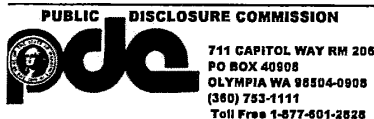

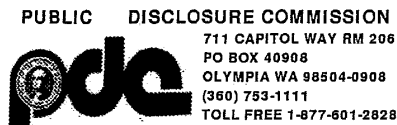

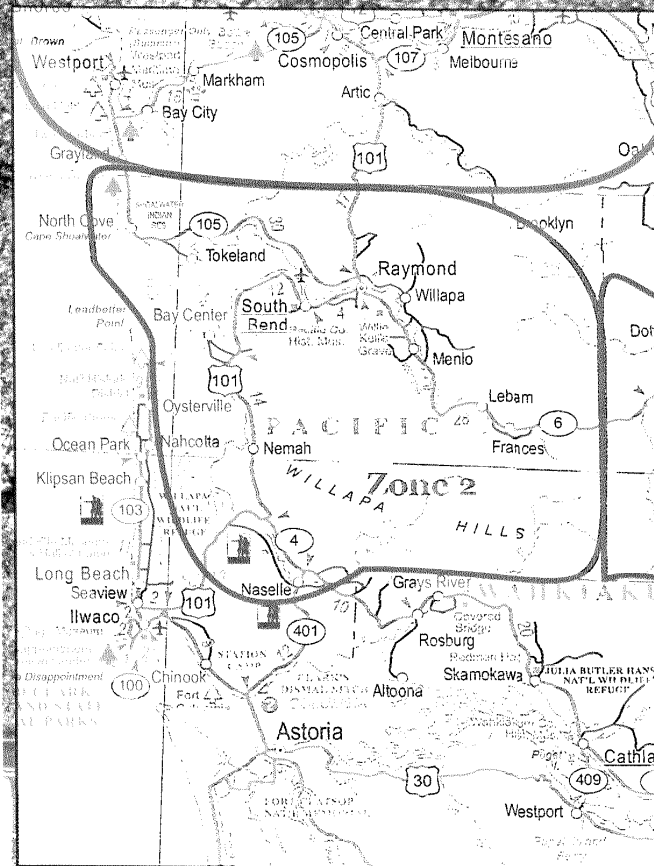

Simple Steps to Protect Yourself from Melanoma Skin Cancer

Dear Savvy Senior,
Does skin cancer run in families? My 63-year-old brother died of melanoma last year, and I'm wondering about my risks of getting this. What can you tell me?

Younger Sibling

Dear Sibling,
While long-term sun exposure and sunburns are the biggest risk factors for melanoma – the deadliest form of skin cancer – having a sibling or parent with melanoma does indeed increase your risk of getting it two to three times.

Each year, about 75,000 Americans are diagnosed with melanoma, and around 10,000 people will die from it. While anyone can get it, those most often diagnosed are caucasians, age 50 and older. And those with the highest risk are people with red or blond hair, blue or green eyes, fair skin, freckles, moles, a family history of skin cancer and those who had blistering sunburns in their youth.

Skin Exams

The best way you can guard against melanoma and other skin cancers (basal and squamous cell carcinomas) is to protect yourself from the sun, and if you're over age 50, get a full-body skin exam done by a dermatologist every year, especially if you're high risk.

Self-examinations done every month or so is also a smart way to detect early problems. Using mirrors, check the front and backside of your entire body, including the tops and undersides of your arms and hands, between your toes and the soles

of your feet, your neck, scalp and buttocks. Be on the lookout for new growths, moles that have changed, or sores that don't heal. Follow the ABCDE rule when examining suspicious moles.

- **Asymmetry:** One half of a mole doesn't match the other.

- **Border:** The border is blurred or ragged.

- **Color:** The mole has uneven colors, often shades of brown, tan or black, with patches of pink, red, white or blue.

- **Diameter:** The lesion is new or at least a quarter-inch in diameter.

- **Evolving:** The mole is changing in size, shape or color.

For more self-examination tips and actual pictures of what to look for, see SkinCancer.org or Melanoma.org.

In the spring and summer, there are a variety of places that offer free skin cancer screenings. Check with the American Academy of Dermatology (888-

462-3376, aad.org/public/spot-skin-cancer), which offers screenings done by hundreds of volunteer dermatologists across the U.S., and the American Society for Dermatologic Surgery (asds.net/skincancerscreening.aspx).

Sun Protection

Even though you can't change your skin or family history, there are some proven strategies that can help you protect yourself.

For starters, avoid tanning beds, and when you go outside, slather on broad-spectrum SPF 30, water-resistant sunscreen on both sunny and cloudy days. If you don't like the rub-on lotions, try the continuous spray-on sunscreens which are easier to apply and re-apply and less messy. Also, seek the shade when rays are most intense – between 10 a.m. and 2 p.m.

You can also protect your skin by wearing a wide-brimmed hat, and long sleeves and pants when possible. The best clothing options are tightly-woven

fabric that help prevent the sun's rays from reaching your skin, or you can wash in an invisible shield sun protection into your clothes with SunGuard laundry additive (see sunguardsunprotection.com). You can even buy a variety of lightweight clothing and hats that offer maximum UV protection in their fabric. Coolibar.com and SunPrecautions.com are two sites that offer these products.

Treatments

If melanoma is caught and treated early, it's nearly 100 percent curable. But if it's

not, the cancer can advance and spread to other parts of the body, where it becomes hard to treat and can be fatal. Standard treatment for melanoma is surgical removal. In advanced cases however, chemotherapy or radiation may also be used, along with a variety of new drug treatments.

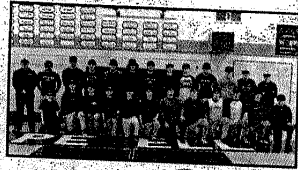

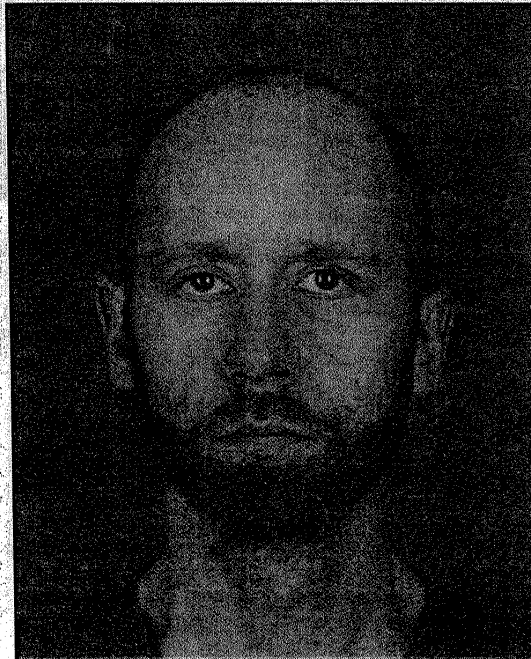
The house was on fire by the time the authorities arrived, and a neighbor was able to notify the deputies

Hello Jacob,

My name is Pat Myers.

I am the treasurer for the Dick Anderson campaign.

As well, I am employed by a newspaper in Pacific County, the Willapa Harbor Herald. My newspaper has endorsed this candidate and has, as such, run independent advertising for this campaign. By independent I mean to say that no conversation has ever been engaged in with the candidate about the advertising that we have done in favor of this campaign. I have had a number of conversations with personnel at the PDC over the past 6 to 8 weeks to ensure that the newspaper nor the candidate are doing anything improperly. Every ad that the newspaper has run regarding the campaign has been registered and reported via the C6 form. I was told by Laura at the PDC that there was no limit on the amount of advertising that we could do for this campaign as long as the candidate was not involved in it in anyway. Laura was also the person who walked me through the C6 form as I was having trouble with it. I thought that my reports were being registered when they, in fact, were not. It turned out that I was not making it all the way through the process. Once I learned of my mistakes I registered a report for every ad that ran. I also understand that since Mr. Anderson is uninvolved in this advertising that it is not required to be declared as a campaign contribution, which this advertising is not intended to be.

And finally, this campaign received a \$500 contribution from the PUD Electrical Workers Union. Before the check was deposited and entered it into the ledger I again called the PDC, I think I spoke with Chip, to make sure that we were in compliance. I include this fact here because I want to impress upon you that I have been diligent in my efforts to stay in compliance.

All in all, at the time of this writing I have spoken with the PDC on 5 separate occasions.

Dear Kurt,

First off, I would like to know if the complainant is a real person. This is a small community and the name Ron Bloom is not familiar to me and his records do not appear locally. I think that it is only prudent for this process to require that actual people are behind the complaints. Please advise.

I would like to start this letter with a set of facts. When I decided to involve the newspaper that I worked for at the time in the running of advertising favoring Mr. Anderson I picked up the phone and called the PDC. I called and asked to speak to a specialist. When the specialist answered I thought she introduced herself as Lori.

I told Lori that the Willapa Harbor Herald would want to run ads in favor of the Dick Anderson campaign. I specifically told Lori that I was an employee of the newspaper company. I specifically told her that I was the treasurer of the Anderson campaign. I specifically told her that I did not own the newspaper. After hearing all of that she replied, "Then you should be okay." She went on to tell me that there was no monetary "cap" on that type of advertising. A fact that I had not yet learned, so the details of the conversation stuck in my memory.

With this knowledge I carried on and ordered advertising based on the information that Lori had given me. I did not make any kind of contact with the candidate when I designed the ads. I did not make contact with the candidate when I scheduled the ad. At no time did Anderson know of the advertising before it ran.

With that said here are my responses to your questions.

1. I met Dick Anderson about 20 years ago on a construction job site.
2. Dick and I had both been independently attending PUD commission meetings for the prior several years. Dick knew that I was "email" friendly, where he was not, so he asked me to help him.
3. We would basically see each other at the PUD meetings twice a month. There were no personal meetings that were set up to discuss his campaign and there was no email correspondence. There were probably a couple of brief phone conversations but I don't remember them.
4. When Dick and I spoke of his campaign it was always only about the reporting and finances of the campaign.
5. Mr. Anderson handled the receiving of contributions. I only remember 1 contribution of \$500 being made.
6. Deposits: I don't remember if I made it or if he did. Since my resignation from this campaign shortly after this complaint was made I no longer have access to those records to verify this information.
7. Payments: Again, this is from memory, so the details are sketchy. I believe that the only service that was paid for out of the campaign account was for one ad that ran in the Long Beach newspaper and I may have written that check. Just not sure at this point.

8. I did not pick up any goods or services.
9. Advertising Discussion: I did not ever discuss any of the advertising that ran in the Herald with Mr. Anderson.
10. I am not employed at the Willapa Harbor Herald since January of this year. At the time I was a publisher/editor/salesman/graphic artist. It is a small weekly paper with 3 full time employees so everyone did everything.
11. Only after talking with specialist Lori and hearing that I was within my rights to do so did I decide, for the Herald, to run the campaign ads that favored Mr. Anderson.
12. The Herald had run many campaign ads for many other candidates in the past. Elections are a major revenue source for newspapers.

In summary, I felt that specialist Lori and the PDC that she was representing were the highest authority on the matter of qualifications for running such advertising and that I had received a green light to run said advertising. Without that review of the facts by Lori and her subsequent "go ahead" those ads would not have been run by the Herald.

Question 1: I do not remember how or if I described which position I held with the company. My usual self introduction is, "Hello, my name is Pat Myers and I am with the Willapa Harbor Herald newspaper".

Question 2: Your questions here lead me to believe that you feel that I was being intentionally deceptive. I guess that I might want to turn this question back to the PDC and ask why the specialist did not ask, after I identified myself as an employee of the newspaper, qualifying questions such as, in your position do you make decisions? When I told here that I was not an owner she simply said, "Then I think you should be ok". That comment to me meant that I was within my rights to move forward with the ads even though I was employed by the newspaper and the campaign treasurer. If specialist Lori had asked those questions and determined that I was not within my rights to run the ads and then came back and said that ...they would not have run.

I am assuming by these questions that it would have been better had I been a reporter rather than a manager. If this is the case, is there a reason that your specialist did not further inquire into my position with that newspaper? Are they trained to ask such questions? The point that I am trying to make here is that your people should have been more diligent if there is a distinction between a decision making employee and one that does not make decisions. The questions should have been asked. I am a neophyte when it comes to elections, politics and campaigns. That is why I called.

Question 3: I have already established that I do not own the paper. The paper is owned by Flannery Properties, a corporation located in Los Angeles, CA. This can be substantiated through the state's corporation licensing department or by my tax returns.

Question 4: Yes.

Question 5: I am unclear as to what you want from this question, it doesn't make sense to me.

Question 6: I attend the commission meetings as an involved citizen of Pacific County. I continue to attend when I can. I did not ever write a news report regarding the PUD. As this utility is part of the democracy that I belong to I am afforded the right to attend commission meetings and every so often be able to add my 2 cents to the discussion.

Question 7: I have attended several city council meetings and county commission meetings in the past. I did not write a news report on any of them.

Question 8: Yes, I did have several conversations with Mr. Anderson during that time. We discussed what we thought was right and wrong about the goings on at the PUD. There were others that I spoke with and whom spoke with me about the same topics during the same timeframe.

Question 9: As I recall, the banner ad was produced and placed in the paper by the production department. I created the message, as I knew of Mr. Anderson's positions from attending the meetings. I produced the large ad and it was placed by the production department.

Question 10: All services are free with the ad. All customers get this. Three of the 4 primary candidates ran ads with the paper. Mr. Brummel was the only one that did not.

Speaking of Mr. Brummel, he has a vendetta against the paper since it reported on his fall from grace several years back when the state caught him selling narcotics over the internet to patients with no or weak doctors prescriptions. He lost his license to practice and he lost his pharmacy. The Herald covered the story. I only bring this up as motive for his accusation.

Question 11: Again, I created the message in the ads because I knew of his positions from attending the meetings. As I have already provided you, I did not discuss any of those ads with Mr. Anderson in advance of them running.

Question 12: I think that the question "why so many" is subjective. I do not think that it was so many. I made the decision to run ads that favored Mr. Anderson because I liked his positions more than those of the other candidates. Had Mr. Anderson not run I believe that candidate Mike Lignoski would have been the benefactor of those ads because I liked most of his positions as well.

Question 13: The newspaper ran news reports on issues that concerned the citizens of the county. Some of those reports included issues that were being dealt with at the PUD. The Willapa Harbor Herald was not the only news agency that was covering the PUD and those issues. The Chinook Observer was also attending and reporting on those issues. Some of the issues included the large management salary increases that happened, they gave themselves a 40% raise, the use of and ultimate destruction of a rented piece of equipment by a PUD manager at his home and for personal use, a 15 year old extension project that had never been completed and was costing the citizens 10s of millions, lack of commission oversight, and so on. The newspaper ran those ads because Mr. Anderson was on the right side of those and other issues. The Chinook Observer also came out in favor of Mr. Anderson during this election.

Question 14: Yes, the Herald ran an insert for Mike Swanson, who was running for PUD Commissioner, he was an incumbent. I have no example to send.

Mr. Myers,

Thank you for your response concerning the Sponsor Identification on your flyer supporting Mike Swanson's 2014 campaign. The Sponsor Identification on political advertising that is required by RCW 42.17A.320 is a requirement to identify the name and address of the person or group who paid for the advertising. Its purpose is not to identify people who generally support the statements in the ad, unless those people actually help pay for the ad. For example, if Richard Andersen agreed with the content of your ad, but did not help pay for it, his name and address should not be included as a sponsor. Since you paid for the ad, your name and address is required to appear in the ad, along with words such as, "Paid for by..." or "Sponsored by ...". You were required to list, in at least ten point font, "Paid for by Pat Myers" followed by your address.

PDC staff does not intend to pursue enforcement action in this instance for your lack of proper sponsor identification. Please ensure that future political advertising includes proper sponsor identification. Failure to do so could result in more formal enforcement action. If you plan to sponsor political advertising in the future, and have questions, please contact the Public Disclosure Commission for guidance. Thank you for your February 26th reply to my questions about the cost of the ad you sponsored supporting Mike Swanson's 2014 reelection campaign for Pacific County PUD Commissioner. It appears that you made an in-kind contribution to Mr. Swanson's campaign totaling \$422.80, which was under the maximum allowable contribution for his campaign, since he selected the Mini Reporting option, which limited him to raising and spending no more than \$5,000 and accepting no more than \$500 from any one contributor. However, there is one additional issue that needs to be addressed.

Sponsor Identification on flyer: The sponsor identification on your flyer stated, **"Paid for by Rate Payers Who Support Responsible Commissioners."** It did not include your name and address, as required by RCW 42.17A.320. As noted in the statute, the use of an assumed name for the sponsor of political advertising is unlawful. Please explain why you used the name Rate Payers Who Support Responsible Commissioners, and omitted your name and address.

RCW 42.17A.320 states, in part, " (1) All written political advertising, whether relating to candidates or ballot propositions, shall include the sponsor's name and address. All radio and television political advertising, whether relating to candidates or ballot propositions, shall include the sponsor's name. The use of an assumed name for the sponsor of electioneering communications, independent expenditures, or political advertising shall be unlawful. For partisan office, if a candidate has expressed a party or independent preference on the declaration of candidacy, that party or

independent designation shall be clearly identified in electioneering communications, independent expenditures, or political advertising. (Emphasis added)

WAC 390-18-010 states, in part, (4) Printed advertising shall clearly state, in an area set apart from any other printed matter, that it has been paid for by the sponsor (Example: (1) Paid for by the XYZ committee, mailing address, city, state, zip code; (2) Vote for John Doe, paid for by John Doe, mailing address, city, state, zip code).

Hello Phillip,

Just got back to the office yesterday and I am happy to oblige.

Here are the costs associated with my donation to Mike Swanson's campaign ad. These are fair market values that the newspaper would charge a paying customer. The design/prepress work would have charged out at \$75 for the Swanson side of the mailer. The press charge for the print job was \$334.80. Half of the print job was for the Swanson side of the mailer which divides down to \$167.40. And the newspaper charges \$82/thousand for insertion and it mails 4,400 pieces a week. This equates to \$360.80 for the entire piece, the Swanson portion divides down to \$180.40. The entire job charge for the Swanson ad is \$422.80.

It has come to the attention of the Public Disclosure Commission that you are the sponsor of the attached flyer that was included in the Willapa Harbor Herald during the 2014 Pacific County PUD Commissioner election, in support of Commissioner Mike Swanson's re-election. I have confirmed with Mike Swanson that you are the sponsor of the attached flyer, and that he did not plan, coordinate, or pay for the flyer.

I need to discuss with you the details of this political advertising to determine whether you were required to report its cost as an Independent Expenditure or Electioneering Communication, and to determine whether you complied with the Sponsor Identification requirements for the flyer. I called your office today and was told you would not be back until after next week. Please contact me immediately upon your return so that we can discuss this matter and determine how to resolve the reporting and sponsor identification issues. I need to know the following:

- The cost of designing and printing the flyer. It appears that half the cost is for pizza coupons and half is in support of Mike Swanson's reelection.
- If you paid the newspaper, the cost for inserting the flyer.
- If you did not pay the newspaper, the fair market value for another person to insert a similar flyer in the newspaper
- The cost of distribution to those receiving the newspaper who did not pay for its distribution.
- Any other costs associated with producing and distributing the flyer.
- The date of distribution
