The Just Want Privacy campaign has failed to follow campaign reporting regulations by reporting nearly \$20,000 in cash contributions nearly a month after they were received by the campaign.

The Just Want Privacy campaign has also been receiving staff time and campaign resources from individuals and organizations that have gone unreported in the campaign's C4 filings as expenditures and/or in-kind contributions.

1. Late Reporting of Contributions

On June 27, 2016, Just Want Privacy's treasurer Tom Perry filed two C3 reports detailing nearly \$20,000 in campaign contributions that were received by the campaign between May 3, 2016 and May 30, 2016, but not deposited until June 22, 2016.

- C3 report filed on 6/27/16 showing \$8,420.00 in late contributions (see attached JWP C3 05 062716)
- C3 report filed on 6/27/16 showing \$10,680.00 in late contributions (see attached JWP C3 02 062716)

These contributions were deposited by the campaign and reported to the PDC nearly a month after they were received. This is a clear violation of campaign finance reporting laws and prevents Washingtonians from having accurate and timely information about who is funding the Just Want Privacy campaign.

2. Family Policy Institute of Washington/Campaign Staff

The Just Want Privacy campaign had been making payroll payments to three staffers, but stopped making payments in May – despite these staffers still maintaining leading roles in the campaign.

The Just Want Privacy C4 filed on 4/11/16 covering the month of March shows the following payments for wages (see attached March C4, filed 4/11/16):

- \$1,193.45 to Joseph Backholm for payroll on 3/31/16
- \$1,116.72 to Mitch Hall for payroll on 3/31/16
- \$1,667.42 to Kaeley Triller Haver for payroll on 3/31/16

The Just Want Privacy C4 filed on 5/10/16 covering the month of April shows the following payments for wages (see attached April C4, filed 5/10/16):

- \$1,664.40 to Mitch Hall for payroll on 4/30/16
- \$1,847.00 to Joseph Backholm for payroll on 4/30/16
- \$2,488.52 to Kaeley Triller Haver for payroll on 4/30/16

However, Just Want Privacy's C4 covering the month of May shows a \$117.99 payment to ADP for "payroll fees", but there are no corresponding wage payments to Backholm, Triller Haver, Hall, or any other campaign staffers for this period (see attached May C4, filed 6/10/16).

Backholm and Triller Haver have been representing the campaign at events and in the press throughout the month of May, so both are clearly still involved with the campaign on an ongoing basis.

There is no reporting from the campaign that takes into account either Backholm's staff time as the chairman of the Family

Policy Institute of Washington and the chairman of the Just Want Privacy campaign or Triller Haver's time as the communications director of Just Want Privacy.

3. Family Research Council

The Just Want Privacy campaign also reports on their Facebook page (see attached screenshot dated 6/24/16) that "even the Family Research Council from Washington DC has lent a hand" in their campaign, but there is no in-kind reporting from the campaign accounting for these additional resources.

4. In-Kinds Reported By Campaign Thus Far

The only in-kind contributions the Just Want Privacy campaign has reported are:

- \$99.81 in petition emails from the Family Policy Alliance in Colorado Springs, CO on 5/17/16 (see attached May C4, filed 6/10/16)
- \$323.00 in Constant Contact emails from FPIW Action in Lynnwood, WA on 3/18/16 (see attached March C4, filed 4/11/16)
- \$287.20 for PO Box rental from FPIW Action in Lynnwood, WA on 2/12/16 (see attached February C4, filed 3/10/16)
- \$66.99 for domain name registration from FPIW Action in Lynnwood, WA on 2/16/16 (see attached February C4, filed 3/10/16)
- \$32.84 for phones from FPIW Action in Lynnwood, WA on 2/17/16 (see attached February C4, filed 3/10/16)
- \$38.33 for Constant Contact email service from FPIW Action in Lynnwood, WA on 2/17/16 (see attached February C4, filed 3/10/16)
- \$157.29 for Office 365 software from FPIW Action in Lynnwood, WA on 2/17/16 (see attached February C4, filed 3/10/16)
- \$110.45 for phone charges from FPIW Action in Lynnwood, WA on 2/17/16 (see attached February C4, filed 3/10/16)

Just Want Privacy reported no in-kind contributions for the month of April in their C4 report filed on 5/10/16.

5. Summary

The PDC should investigate late reporting of contributions and unreported in-kind contributions to the Just Want Privacy campaign and levy applicable fines if they are found to be in violation of Washington's campaign finance reporting laws.
