Administrative Charges

I. JURISDICTION

The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the state campaign finance and disclosure laws; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC. These charges incorporate the Report of Investigation and all related exhibits by reference.

II. ALLEGATIONS

PDC staff alleges that the Benton County Democratic Central Committee (BCDCC) violated: (1) RCW 42.17A.235 and .240 by failing to timely report contributions deposited between October 17, 2013 and October 31, 2016, totaling \$18,503.10, and expenditures made between September 1, 2014 and November 30, 2016, totaling \$34,707.41; (2) RCW 42.17A.205 by failing to file updated committee registration forms disclosing a change in treasurers on two occasions; and RCW 42.17A.235(6) by failing to preserve books of account concerning its contributions received.

III. FACTS

1. On August 24, 2015, Marilyn Moore filed a complaint with the Public Disclosure Commission (PDC) alleging that the Benton County Democratic Central Committee had not filed any reports with the PDC since October 13, 2014. PDC staff confirmed that as of the date of the complaint, the last C-4 report of contributions and expenditures on file was received October 15, 2014, covering the period October 1, 2014 through October 14, 2014.

2. On September 16, 2015, PDC staff sent a copy of the complaint to the BCDCC, and on September 30, 2015, Jhoanna Jones, newly appointed BCDCC Treasurer, sent an email to PDC staff stating she had completed the missing reports for 2015, and would forward the reports to the PDC as soon as they were signed.
3. The reports were not received from Ms. Jones as promised, and on February 8, 2016, PDC staff sent another request for a response to the complaint to the Chair, Vice Chair, and Secretary of the BCDCC.
4. On February 12, 2016, staff received an email from Regina Speer, stating she became Chair of the BCDCC on January 20, 2016. She said she asked Ms. Jones to resign as Treasurer, which she did. Ms. Speer said the only documentation she received from Ms. Jones was three months of bank statements. Ms. Speer also said there was a Treasurer before Ms. Jones' short tenure, who did not forward any documentation of her work to Ms. Jones. As of February 21, 2016, the most recent C-1pc committee registration listed Jay Clough Chair, Rebecca Voll, Vice Chair, and Fatema Karim, Treasurer.
5. On February 22, 2016, Michele Levenite submitted a C-1pc listing the following new committee officers: Regina Speer, Chair and Michele Levenite, Treasurer.
6. Ms. Levenite identified two fundraisers for which adequate records were not kept: (1) A May 2015 Norm Miller Leadership Dinner fundraiser, a \$75 per person fundraiser; and (2) a December 4, 2015, All Democrats Holiday Party Celebration Winter Fests around the World fundraiser, a \$40.00 per person fundraiser. Ms. Levenite worked with the bank and reconstructed a list of contributors for both fundraisers.
7. On behalf of the BCDCC, Ms. Levenite filed multiple missing reports between July 27, 2016 and December 13, 2016. These reports included 18 late-filed C-4 reports totaling \$34,707.41 in expenditures. The C-4 reports were filed between 1 and 638 days late, and included expenditures made between September 1, 2014 and November 30, 2016. Ms. Levenite also submitted 45 late-filed C-3 reports totaling \$18,503.10. The C-3 reports were filed between 8 and 632 days late, and included deposits made between October 17, 2013 and October 31, 2016.

IV. LAW


RCW 42.17A.205 – Statement of organization by political committees. States in part: Every political committee shall file a statement of organization with the commission. The statement must be filed within two weeks after organization or within two weeks after the date the committee first has the expectation of receiving contributions or making expenditures in any election campaign, whichever is earlier. Subsection 4 also states that

any material change in information previously submitted in a statement of organization shall be reported to the commission within the ten days following the change.

RCW 42.17A.210 – Treasurer. States in part: In the event of the death, resignation, removal, or change of a treasurer or deputy treasurer, the candidate or political committee shall designate and file with the commission the name and address of any successor.

RCW 42.17A.235 and .240 require candidates and continuing political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report. C-4 reports are also required 21 and 7 days before each election in which the committee makes expenditures, and in the month following the election. Contributions are reported weekly during this same time period, and must be disclosed on Monday for contributions deposited the previous seven days. Subsection 6 of RCW 42.17A.235 states that the treasurer or candidate shall preserve books of account, bills, receipts, and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred.

Amended Report of Investigation

I.

Background and Introduction

- 1.1 On August 24, 2015, Marilyn Moore filed a complaint with the Public Disclosure Commission (PDC) alleging that the Benton County Democratic Central Committee (BCDCC) had not filed any reports with the PDC since October 13, 2014. The complaint also stated that the BCDCC had held reorganization meetings and elected two different treasurers since October 13, 2014, without filing the required updates to its committee registration statements reflecting those changes. The complaint also stated that the BCDCC had held several fundraisers, with at least one rising above the level of a "low cost fundraiser" which required the disclosure of detailed contributor information.
- 1.2 During the investigation, the BCDCC appointed a new chair and treasurer who worked diligently to reconstruct the committee's contribution and expenditure activities since October 2014, which included identifying contributors to fundraisers for which adequate records were not kept.
- 1.3 Political committees are required by RCW 42.17A.205 to register with the Public Disclosure Commission, using form C-1pc. Registration is required within two weeks of expecting to receive or receiving contributions, or making expenditures in any election campaign, whichever is earlier. In addition, political committees are required by RCW 42.17A.205(4) to submit an updated C-1pc when there has been a material change in information previously submitted in a statement of organization, such as appointing a new treasurer. The updated C-1pc is required to be submitted within 10 days of the change. In accordance with RCW 42.17A.235 and .240, political committees are required to file periodic C-3 reports of monetary contributions received, and C-4 reports disclosing in-kind contributions and monetary expenditures. Political committees are also required by RCW 42.17A.235(6) to preserve books of account, bills, receipts, and all other financial records for not less than five calendar years following the year during which the transaction occurred.

II. **Allegations**

- 2.1 The Complaint alleged that the Benton County Democratic Central Committee may have violated RCW 42.17A.235 and .240 by failing to report the receipt of contributions received and expenditures made since October 13, 2014, and RCW 42.17A.205 by failing to timely update its committee registration when it changed treasurers. **(Exhibit 1)**

III. **Findings**

- 3.1 The Benton County Democratic Central Committee is a political committee required to register and report with the Public Disclosure Commission. The committee has been filing C-3 and C-4 reports with the PDC since at least 1996, disclosing its contributions and expenditures.
- 3.2 Following the receipt of Ms. Moore's complaint on August 24, 2015 that cited a significant lapse in reporting, the committee elected a new chair, Regina Speer, and a new treasurer, Michele Levenite, researched the committee's lack of reporting, reconstructed lists of donors to past fundraisers, and filed multiple missing reports between July 27, 2016 and December 13, 2016. There were 18 late-filed C-4 reports, filed from 1 to 638 days late, that included \$34,707.41 in expenditures made between September 1, 2014 and November 30, 2016 **(Exhibit 2)**. There were 45 late-filed C-3 reports, filed from 8 to 632 days late, that included \$18,503.10 in contributions deposited between October 17, 2013 and October 31, 2016 **(Exhibit 3)**.
- 3.3 On September 16, 2015, PDC staff provided a copy of the complaint to the BCDCC. The letter asked committee officials to review the complaint, take any required corrective action, and provide a written response to the allegations by September 30, 2015. Staff asked BCDCC officials to explain why they had not filed any reports since October 2014, why they had not updated their committee registration when they changed treasurers, and why they had not disclosed details of the committee's fundraisers **(Exhibit 4)**.
- 3.4 On September 29, 2015, Jhoanna Jones notified PDC staff that she had recently been appointed Treasurer of the BCDCC. Although Ms. Jones acknowledged that certain forms needed to be forwarded to the PDC, she did not acknowledge that she had received a copy of the complaint.
- 3.5 On September 30, 2015, staff received an email from Ms. Jones stating she had completed the missing PDC reports for 2015, and saying she would be forwarding the reports to the PDC as soon as the reports were signed.
- 3.6 PDC staff did not receive the missing reports as promised or a written response to the allegations as requested, and on January 22, 2016 requested an explanation. Ms. Jones answered by email on January 22, 2016, stating she had forwarded the reports online and stating she had resigned as Treasurer for medical reasons. Staff did not receive the reports.

- 3.7 On February 8, 2016, staff resent the complaint to the email addresses of the BCDCC Chair, Vice Chair and Secretary.
- 3.8 On February 12, 2016, staff received an email from Regina Speer, stating she became Chair of the BCDCC on January 20, 2016. She said that immediately after she became Chair, she asked Ms. Jones to resign as Treasurer, which she did. Ms. Speer said the only documentation she received from Ms. Jones was three months of bank statements. Ms. Speer also said there was a Treasurer before Ms. Jones' short tenure, who did not forward any documentation of her work to Ms. Jones.
- 3.9 As of February 21, 2016, the most recent C-1pc committee registration listed Jay Clough Chair, Rebecca Voll, Vice Chair, and Fatema Karim, Treasurer.
- 3.10 On February 25, 2016, staff received an email from Michele Levenite, stating she had recently become the new BCDCC Treasurer. She timely filed an updated committee registration, and said she was in the process of having signature cards updated at the bank. PDC staff suggested that Ms. Levenite first concentrate on filing the missing reports for 2016, and then start working on the 2015 and the 2014 reports.
- 3.11 On September 21, 2014, the BCDCC submitted a C-1pc listing Fatema Karim as Treasurer (**Exhibit 5**). Even though the BCDCC had two people serve as Treasurer after Fatema Karim and before Michele Levenite, no C-1pc forms were submitted to document these changes in Treasurers until Michele Levenite submitted a C-1pc on February 22, 2016, listing the following new committee officers: Regina Speer, Chair and Michele Levenite, Treasurer (**Exhibit 6**).
- 3.12 On February 25, 2016, staff reviewed the PDC's database and confirmed that the BCDCC had not submitted a C-4 Summary Report of Receipts and Expenditures since October 15, 2014.
- 3.13 Ms. Levenite worked diligently to reconstruct the records of the BCDCC, and informed PDC staff that the committee held two fundraisers in 2015: (1) In May 2015, the BCDCC held the Norm Miller Leadership Dinner as a \$75.00 per person fund raiser. The names, addresses and amounts received from each contributor were not recorded. The only names Ms. Levenite was able to find were those who used credit cards to pay for the event. (2) In addition, there was a fundraiser on December 4, 2015, the All Democrats Holiday Party Celebration Winter Fests around the World, for \$40 per person. There was a third fundraiser listed on the BCDCC calendar for January 17, 2015, a Martin Luther King Jr. Event, but Ms. Levenite explained that this event was not sponsored by the BCDCC. It was listed on the BCDCC calendar as a reminder for its members.
- 3.14 As explained above, the BCDCC filed multiple missing reports between July 27, 2016 and December 13, 2016. These reports included 18 late-filed C-4 reports totaling \$34,707.41 in expenditures. The C-4 reports were filed between 1 and 638 days late, and included expenditures made between September 1, 2014 and November 30, 2016. These reports also included 45 late-filed C-3 reports totaling \$18,503.10. The C-3 reports were filed between 8 and 632 days late, and included deposits made between October 17, 2013 and October 31, 2016.

- 3.15 Following 2016, the BCDCC held an election of officers, and on January 10, 2017, filed a new Committee Registration listing David Rose, Chair and Stacy Cash-Ware, Treasurer (**Exhibit 7**).

IV.

4.1 PDC staff reviewed the following:


- Complaint submitted by Marilyn Moore concerning alleged reporting violations by the Benton County Democratic Central Committee. The complaint was received on August 20, 2015.

We are writing to let you know that on August 24, 2015 the Washington Public Disclosure Commission (PDC) received a complaint from Marilyn K. Moore alleging that the Benton County Democratic Central Committee may have violated RCW 42.17A, the state's campaign disclosure and contribution law. A copy of the complaint is enclosed for your information.

PDC staff reviews all complaints to determine whether sufficient information has been provided and if an investigation is warranted. The complaint filed against you has been assigned tracking number 15-069. Please refer to this tracking number when corresponding with PDC staff about your complaint.

For your information, PDC staff reviews and investigates complaints in accordance with the Administrative Procedures Act. Once a complaint has been received, staff notifies the Respondent (the subject of the complaint) and provides a copy of the complaint along with an initial opportunity to respond to the allegations by submitting a written response, either by letter or by email.

Staff considers all responses received as part of its initial review, and based on that review, complaints are either returned, dismissed with no or minor action, or assigned to an investigator for further investigation. Once an investigation is opened, staff will contact the Respondent either to: (1) obtain a supplemental response; (2) request additional information or documentation; or (3) conduct an investigative interview under oath, either in-person or by telephone. Any violations and penalties the Commission assesses against Respondents are civil in nature.

Please review the complaint, take any required corrective action, and provide a written response to the allegations by no later than September 30, 2015. Staff is requesting that you answer the following:


- The Benton County Democratic Central Committee has not filed any reports since October 13, 2014, to include no C1's have been filed updating the name of the individuals who have held the office of treasurer.
- It has been reported there have been fund raisers which may require more detailed reporting.

Your timely response will assist staff in processing your complaint. Thank you for your cooperation.
