Dear Steve White:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on September 21, 2018. Your complaint alleged that Gina Mosbrucker may have violated RCW 42.17A.330 by using political advertising that does not contain at least one picture of the candidate taken within the last five years.

PDC staff reviewed your allegations and, as a result of staff’s initial review, found the following:

- The photographs of Gina Mosbrucker provided by the Complainant were taken professionally between 2014-2018 and therefore do not violate RCW 42.17A.330.

Based on these initial findings, staff has determined that, in this instance, no evidence supports a finding of a violation warranting further investigation.

The PDC has dismissed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
