Sporting Systems is operating what it describes as a “campaign” against Initiative 1639, including making expenditures, without disclosing any information to the Public Disclosure Commission, as detailed in the attached complaint.

To Whom It May Concern:

This is a formal Public Disclosure Commission complaint, filed due to violations of Chapter 42.17A of the Revised Code of Washington. Sporting Group Corporation of Washington, a Washington corporation operating as "Sporting Systems" at 408 W. 9th St, Vancouver, Washington, 98660, along with registered agent Daniel Mitchell are accused of violating the following statute:

RCW 42.17A.205

Violations and Evidence

Sporting Systems has been operating as a de facto political committee in opposition to Initiative 1639. The corporation has made expenditures and distributed materials in opposition to the measure without filing legally required disclosure forms (they are operating as a campaign outside the bounds of PDC regulation).

On or before June 18, 2018, Sporting Systems began actively working to oppose Initiative 1639.

Sporting Systems began using an outside vendor to print materials in opposition to Initiative 1639 on or before September 7, 2018. They have stated they have paid to print at least ten thousand pieces of literature in opposition to Initiative 1639. None of these materials identify a political committee sponsor, nor do they provide information about donors.

No later than September 8, 2018, Sporting Systems began describing their activities against Initiative 1639 as a "campaign."


On September 13, 2018, Sporting Systems provided food, drinks, materials, and "coordination" for a campaign meeting held with the express purpose of training people to oppose Initiative 1639

Neither Sporting Systems nor registered agent Daniel Mitchell appear to have filed any paperwork establishing a committee, nor have any of their actions been undertaken on behalf of an existing committee.


