I received at my home address on 10/20/2018 a flyer from “Real Progressives in Thurston County.” The “sponsor” is “A Brighter Thurston County.” The contact is Glen Morgan, ExecutiveDirector@WAProgressiveVotersforChange.com, 1001 Cooper Point Road SW #140-222 Olympia, WA 98502. It was mailed from Spokane under postal permit #285. This flyer was completely misleading and used the logo of Fuse without their permission (I know this because of an alert I received that morning from Fuse). The flyer was used to defraud. It urged a write in campaign on behalf of EJ Zita, presumably without her consent. It urged voters to vote against Tye Menser.

What impact does the alleged violation(s) have on the public?

Misleads voters with the express intent of altering the outcome of an election.

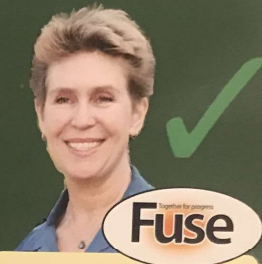

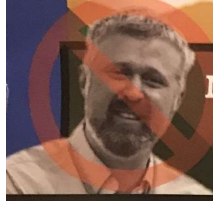
