A fraudulent election campaign flyer was delivered to my mailbox. It attempted to steal my vote by asking me to vote for a person who is not registered in the campaign for Thurston County Commissioner. If I did, my vote would not count. This is a violation of RCW 42.17A.335 The person listed as Executive Director is Glen Morgan. The PAC listed is A Brighter Thurston County. The major contributor to A Brighter Thurston County is the Thurston Republican Party.

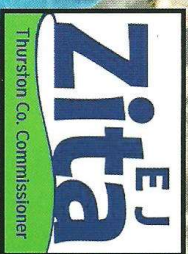

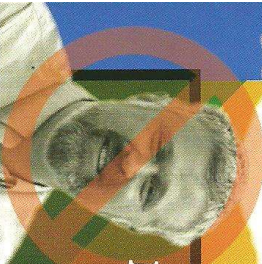
