Dear Ms. Blacksmith:

I am replying on behalf of the Committee to Elect Drew MacEwen (the Committee) to your email of October 24, 2018 requesting a response to a complaint filed by Sandra Giachino on October 9, 2018, PDC Case No. 42179. Ms. Giachino alleges that a phone call she received on or around August 22, 2018 that was sponsored by the Committee contained false information about a candidate for the legislature, David Daggett.

Attached for your consideration is an audio file of the automated phone call that Ms. Giachino received. Also attached is a copy of an NRA scorecard featuring NRA ratings of the candidate referenced in the phone call. As is readily apparent, Ms. Giachino has not accurately portrayed the content of the phone call.

Ms. Giachino also hasn't provided any evidence that Mr. Daggett's positions are any different than as characterized on the call. Given this information, no violation of RCW 42.17A.335(1)(a) can be sustained, and the complaint should be dismissed
