What impact does the alleged violation(s) have on the public?

The impact on the public is the lack of accurately and timely reporting while trying to use the PDC for his campaign benefit against his opponent. The failure to timely and accurately report contributions, expenditures and debt. This candidate has not filed a single full reporting requirement while specifying he doesn't need to follow the laws. No election filing fees, use of phone or location as campaign expenditures or bank fees for campaign account itemized for "rental" or value of use are 4 examples of neglected expenses for either candidate or campaign manager at same address. As full reporting in June, July, August, September are not in compliance.


