Report of Investigation

**I.**

**Background. Complaint and Allegations**

- 1.1 The North Cascade Jobs Enterprise Washington is a political committee registered with the Public Disclosure Commission (PDC) and has been filing committee campaign finance reports since April 28, 2016.
- 1.2 Enterprise WA Jobs PAC has been registered with the PDC as a political committee since 2008.
- 1.3 On October 17, 2017, the Committee filed an amended (C-lpc report) as a continuing political committee, selecting the Full Reporting Option and listing Jeffrey D Harvey as President, Gary Strannigan as Treasurer, Janette Roberts as Financial Controller and Patti Case as Committee Officer. **Exhibit #1.**
- 1.4 On March 2, 2018, the Committee filed an amended C-lpc report as a continuing political committee, selecting the Full Reporting Option and listing Jeffrey D Harvey as President, Jon Devaney as Chairman/Committee Officer, Gary Strannigan as Treasurer and Janette Roberts as Financial Controller. **Exhibit #1.**
- 1.5 On October 7, 2018, the North Cascade Jobs Enterprise Washington PAC (Committee) filed an amended Committee Registration (C-lpc report) with the PDC indicating it was a continuing political committee, selecting the Full Reporting Option and listing Jeffrey D. Harvey as President, Jon Devaney as Chairman/Committee Officer, and Gary Strannigan as Treasurer. There was no Financial Controller listed on the amended C-lpc report. **Exhibit #1.** The C-lpc report also disclosed that the Committee was directed, sponsored and affiliated with Enterprise WA Jobs PAC.

- 1.6 For the 2018 election, Enterprise WA Jobs PAC was registered with the PDC as a continuing political committee, filing Monetary Contributions reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports) that disclosed \$1,780,193 in total contributions received and \$1,758,615 in total expenditures made.
- 1.7 There were also four other political committees sponsored, directed and affiliated with Enterprise WA Jobs PAC during 2018 that included Citizens for Progress Enterprise Washington; Our Olympic Communities Enterprise Washington; People For Jobs Enterprise Washington; and South Sound Future PAC Enterprise Washington. The overwhelming majority of the \$1,758,615 in Enterprise WA Jobs PAC expenditures made in 2018, were made as contributions/transfers to the other five affiliated committees.
- 1.8 On October 17, 2018, Samantha Kersul filed a complaint with the PDC alleging that the Committee violated RCW 42.17A.260 by failing to file Independent Expenditure reports (C-6 reports) disclosing cable television advertisements being aired in Whatcom County in opposition to Pinky Vargas, a candidate seeking the office of State Senator in the 42<sup>nd</sup> Legislative District, and a website established to also oppose Ms. Vargas. Ms. Kersul also attached a contract order for a \$49,245 media buy with Comcast Spotlight Advertising on behalf of the Committee by Medium Buying LLC. **Exhibit #2.**
- 1.9 The Committee has no prior PDC violations.

## II. Investigative Findings

- 2.1 Political committees that selected the Full Reporting option, and participated in the 2018 primary and general elections by either making or receiving contributions, or making independent expenditures or electioneering communications to support or oppose candidates, were required to file the following reports in calendar year 2018:
  - Monetary contributions must be deposited into the committee bank account within five business days of receipt, and the Committee is required to file one C-3 report for each bank deposit. Monthly C-3 reports are due to be filed by the 10th of each month disclosing contributions received and deposited during the previous calendar month, and weekly C-3 reports are required to be filed every Monday beginning June 1 through November 5, 2018, for contributions received and deposited the previous five business days.
  - Monthly C-4 reports are required to be filed for the periods January 1 through May 31, 2018, and December 1 through 31, 2018, and are due by the 10th of the month if \$200 in contributions has been received or \$200 in expenditures have been made since the last C-4 report was filed.
  - A 21-day Pre-Primary Election C-4 report was required on July 17, 2018, covering the period June 1 through July 16, 2018; and a 7-day Pre-Primary Election C-4 report was required on July 31, 2018, covering the period July 17 through July 30, 2018.

- Special reports are required July 31 – August 6, 2018 and October 16 – November 5, 2018 if the committee makes or receives contributions of \$1,000 or more from one source.
- A Post-Primary Election C-4 report was required by September 10, 2018, covering the period July 31 through August 31, 2018.
- A 21-day Pre-General Election C-4 report was required on October 16, 2018, covering the period September 1 through October 15, 2018; and a 7-day Pre-General Election C-4 report was required on October 30, 2018, covering the period October 16 through October 29, 2018.
- A Post-General Election C-4 report was required by December 10, 2018, covering the period October 30 through November 30, 2018.

2.2 For 2018, political committees making independent expenditures or electioneering communications were required to file C-6 reports as follows:

- Box #1 of the C-6 report - Independent Expenditures of \$100 or more (RCW 42.17A.255): A political committee registered with the PDC and filing C-3 and C-4 reports is exempt from filing C-6 reports disclosing independent expenditures that meet this statutory definition.
- Box #2 of the C-6 report - Independent Expenditure Political Advertising of \$1,000 or more within 21-Days of an election (RCW 42.17A.260): A political committee is required to file a C-6 report within twenty-four hours after the date it first publishes, mails, or otherwise presents political advertising in the form of independent expenditures valued at \$1,000 or more to the public, within 21 days of an election.
- Box #3 of the C-6 report – Electioneering Communications Advertising of \$1,000 or more within 60-Days of an election (RCW 42.17A.305): A political committee is required to file a C-6 report within twenty-four hours after the date it first publishes, mails, or otherwise presents political advertising in the form of an electioneering communication valued at \$1,000 or more to the public, within 60 days of an election, that features or mentions a candidate for public office.

2.3 On March 12, the Committee filed its initial C-4 report for the 2018 election, disclosing \$1,520 in committee funds carried forward from CY 2017, with no new contribution or expenditure activities disclosed.

2.4 The Committee timely filed C-4 reports on April 12, May 10, June 11, July 17, July 31 and September 10, 2018, each disclosing zero contribution and expenditure activities.

2.5 The Committee timely filed all three of its required C-3 reports for the 2018 election, disclosing the receipt of \$190,000 in monetary contributions, all from Enterprise WA Jobs PAC.

- 2.6 Enterprise Washington Job's PAC was the Committee's only contributor for the 2018 election. The three C-3 reports filed by the Committee included: a C-3 report timely filed on October 7, 2018, disclosing a \$20,000 monetary contribution deposited on October 1, 2018; and two C-3 reports timely filed on October 15, 2018, disclosing a \$35,000 monetary contribution deposited on October 10, 2018, and a \$135,000 monetary contribution deposited on October 15, 2018.

#### **Failure to timely file C- 6 reports**

- 2.7 RCW 42.17A.305 requires Electioneering Communications advertisements to have all of the following four characteristics (1) the communication clearly identifies at least one candidate for state, local or judicial office; (2) the communication appears within 60 days of an election in the candidate's jurisdiction; (3) the communication appears in one or more of the following media – radio, television, postal mailing, billboard, newspaper or periodical; and (4) the communication either alone, or in combination with other communications by the sponsor identifying the candidate, has a fair market value of \$1,000 or more. In addition, electioneering communications must be reported electronically within 24 hours of, or on the first working day after, the date the communication was first broadcast, mailed, erected, or published.
- 2.8 On January 17, 2019 the Committee filed eight C-6 reports and amended one C-6 report. The Committee also filed one amended C-6 report on January 18, 2019. On each, the Committee checked Box #1 on the report indicating they made independent expenditures totaling \$164,316 in opposition to Pinky Vargas, a candidate for State Senator in the 42<sup>nd</sup> Legislative District, and in support of Doug Erickson for State Senator in the 42<sup>nd</sup> Legislative District.
- 2.9 On February 1, 2019, the Committee filed 12 C-6 reports checking Box #3 for Electioneering Communications of \$1,000 or more appearing within 60 days of an election and disclosing expenditures made during the period October 9 through November 2, 2018, for electioneering communication advertisements totaling \$182,323 made in opposition to Pinky Vargas, and \$7,868 in support of Doug Ericksen. **Exhibit #3.**
- 2.10 The C-6 reports filed by the Committee on February 1, 2019, included all the expenses filed January 17, 2019, however, in some cases, were broken down in greater detail, plus two new additional C-6 reports were filed by the Committee.
- 2.11 The C-6 reports disclosed \$190,191 in Committee expenditures made for electioneering communications advertisements as detailed in the chart below, were filed between 88 and 114 days late, and more than 87 days after the general election. The C-6 reports disclosed the following activities:
- \$104,259 for 12 direct mail electioneering communication advertisements that were presented to the public between October 9 through November 2, 2018.

- \$52,325 in cable television electioneering communications advertisements that ran during the period October 10 through November 6, 2018.
- \$33,607 for Facebook and other social/digital media electioneering communications advertisements that ran during the period October 10 through November 6, 2018.

2.12 As noted in the chart above and on the C-4 reports filed by the Committee, all the vendors listed on the C-6 reports were out of state political and media consultants/firms from Ohio, Virginia, and Florida.

2.13 There was one additional issue concerning the limitations of the C-6 electronic filing application which required the Committee to manually file the previously electronically filed C-6 reports on paper. PDC staff informed the Committee on March 6, 2019 and requested the Committee manually re-file the previously electronically filed C-6 reports on paper. On March 12, 2019, the Committee manually re-filed the previously electronically filed C-6 reports.

#### **Failure to timely and accurately file C-4 reports**

2.14 RCW 42.17A.240 requires political committees under the Full Reporting option to accurately file C-4 reports disclosing contribution and expenditure information, including the name and address of each person to whom an expenditure was made in the aggregate amount of more than fifty dollars during the period covered by this report, the amount, date, and a detailed description or purpose of each expenditure, and the total sum of all expenditures.

2.15 In addition, PDC rules and reporting requirements require political committees to identify any candidate supported or opposed by an expenditure, and to provide the purpose and the goods or services provided by the expenditure.

#### **21-Day Pre-General Election C-4 report:**

- On October 16, 2018, the Committee timely filed its 21-day Pre-General Election C-4 report disclosing \$190,000 in contributions received and three expenditures totaling \$35,531.

- The three expenditures included the descriptions listed as poll data (\$2,331), polling (\$13,000) and media advertisements (\$20,200). The C-4 report disclosed no outstanding debts or obligations.
- On February 6, 2019, the Committee amended its 21-day Pre-General Election C-4 report disclosing the same \$190,000 in contributions received and listed \$88,286 in expenditures made (which included the \$35,531 for the three previously disclosed expenditures) and \$39,265 in debt/liabilities. **Exhibit #4.**
- The \$52,755 in previously unreported expenditures were all made in opposition to Pinky Vargas and disclosed: (1) three direct mail electioneering communications advertisements totaling \$22,523 (for 11,010 to 14,153 mail pieces); (2) \$11,647 for Facebook electioneering communications advertisements running 10/10 – 11-6; (3) \$14,700 for Mobile electioneering communications advertisements running 10/10 – 11-6; (4) \$2,625 for Media Production; and (5) \$1,260 for a website landing page.
- The \$39,265 in previously unreported debts and obligations included \$29,500 owed to Media Buying LLC in Columbus, Ohio for Cable TV electioneering communications advertisements opposing Pinky Vargas and running 10/10 – 11/6; and \$9,766 for a direct mail electioneering communications advertisement for 14,153 mail pieces. The amended expenditure and debt information was disclosed 113 days late and 92 days after the 2018 general election.

#### 7-day Pre-General Election C-4 report

- On October 30, 2018, the Committee timely filed its 7-day Pre-General C-4 report disclosing zero contributions received during the period, no expenditures were made, no debts or obligations were outstanding, and a \$155,989 cash on hand balance.
- On February 6, 2019, the Committee amended its 7-day Pre-General Election C-4 report disclosing the same \$190,000 in contributions received and listed \$40,896 in previously unreported expenditures, and \$52,271 in previously unreported debts and liabilities. **Exhibit #5.**
- The \$40,896 in previously unreported expenditures were all made in opposition to Pinky Vargas and were for four direct mail electioneering communications advertisements that included between 11,010 to 14,153 mail pieces. The \$52,271 in debts and obligations included the \$29,500 owed to Media Buying LLC in Columbus, Ohio for Cable TV electioneering communications advertisements opposing Pinky Vargas that was disclosed on the amended 21-Day Pre-General Election C-4 report.
- The previously unreported debts and obligations included \$22,771 for three direct mail electioneering communications advertisements in opposition to Pinky Vargas. The amended expenditure information was disclosed 99 days late and 92 days after the 2018 general election.

Post-General Election C-4 report:

- On December 10, 2018, the Committee timely filed its Post-General C-4 reports, listing zero contributions and \$140,231.85 in expenditures. The report included four expenditures listed with a date paid of October 31, 2018 and two listed with a date paid of November 2, 2018. All were listed as “Digital Media.”
- On February 6, 2019, the Committee amended this report, listing only \$46,580 in expenditures that were made October. The amended expenditure information deleted \$93,651 that was included on the amended 21-Day and 7-Day Pre-General Election C-4 reports. The amended expenditure information was disclosed 58 days late. **Exhibit #6.**

December 2018 C-4 report (Final Report)

- The Committee timely filed its final C-4 on January 10, 2019, listing zero contributions and zero expenditures, with a \$15,757.28 balance.
- The Committee amended this report February 6, 2019, listing \$29,759 in outstanding liabilities. The amended report was disclosed 27 days late.

Response from the Committee

- 2.16 PDC staff made numerous attempts to contact the Committee via email (October 30, December 10 and December 26, 2018) and telephone (December 12 and December 19, 2018) between October 28 and December 26, 2018 but the Committee failed to acknowledge receipt of the complaint or provide a response as noted in the Scope of this Report of Investigation.
- 2.17 On December 30, 2018, Jeff Harvey, President, Enterprise Washington, stated via email “I will have an official response before January 3<sup>rd</sup>.”
- 2.18 January 2, 2019, the Committee’s initial response received by the PDC from Dan Brady, legal counsel for Enterprise Washington, was an email stating “I am representing the North Cascades Jobs Enterprise Washington Committee sponsored by Enterprise Washington (the “Committee”) in the matter referenced in this email. After review of the complaint and discussions with Mr. Harvey, it is clear that a combination of incorrect committee contact information on file with the PDC and the transition to a new compliance system/staff led to a gap in committee reporting. It is the intent of the committee to gather data and amend and/or file reports addressing this complaint within two days – January 4, 2018. Once this process is complete I will immediately send you a formal response to the complaint. I the meantime, please contact me at any time with any questions or to discuss further.” **Exhibit #7.**
- 2.19 On January 22, 2019, Mr. Brady supplemented the response, stating, “as you are aware, North Cascade Jobs Enterprise Washington (NCJ) indicated early this month its intent to gather data and immediately amend or file reports as required to address PDC Case No. 42387.”



- 2.20 Mr. Brady further stated “[u]nfortunately, significant technical difficulties in filing were encountered almost immediately, and despite extensive work with PDC staff, were not resolved until last week when PDC technical staff on January 16, 2019 finally suggested that NCJ create a new account and refile reports.” He added that on, “January 18, 2019, C-6 #9040 was filed which addresses the concerns raised in this case. NCJ regrets the oversight in not disclosing this advertising previously. Please note that the website cited in the case was presented to the public on October 10, 2019 in concurrence with the TV advertising.” **Exhibit #8.**

### **III.** **Scope**

- 3.1 PDC staff reviewed the following:

- The complaint and exhibits filed on October 17, 2018, by Samantha Kersul against North Cascade Jobs Enterprise Washington PAC.
- Telephone conversations and email communications with Dan Brady, on behalf of North Cascade Jobs Enterprise Washington PAC.
- C-1pc, C-3, C-4 and C-6 reports filed North Cascade Jobs Enterprise Washington PAC from the time period covering the 2018 primary and general election.

- 3.2 PDC staff queried the PDC database for North Cascade Jobs Enterprise Washington PAC contribution and expenditure information covering calendar year the period of January 1, 2018 through December 31, 2018.

- 3.3 Chronology of PDC staffs attempted contacts with the Committee concerning the complaint:

- Email with attached complaint sent to janette@enterprisewashington.org, the Committee email address listed on its current C1-pc, on October 30, 2018. (No response received).
- Email with attached complaint sent to janette@enterprisewashington.org and jeff@enterprisewashington.org on December 10, 2016. (No response received)
- Phone call to Jeffrey Harvey, listed on C1-pc as Campaign Manager for North Cascade Jobs Enterprise Washington on December 12, 2018. (Voice mail left, no response received.)
- Phone calls December 19, 2018 to Jeffrey Harvey, Tyler Mason, listed on the Enterprise Washington website as Campaign Manager and Patti Case, listed on previous C1-pc as Campaign Manager. (Voice mails left, no response received).

- Email with attached complaint sent to janette@enterprisewashington.org and jeff@enterprisewashington.org and pcase@greendiamond.com (email found from web search) on December 26, 2018. (Response received from Jeff Harvey December 30, 2018.)

#### IV. Statutes


- 4.1 **RCW 42.17A.005(19)** "Electioneering communication" means any broadcast television or radio transmission, US Postal Service mailing, billboard, newspaper, or periodical that clearly identifies a candidate for a state, local, or judicial office (by name or identifying the candidate without using his/her name, and is broadcast, transmitted, mailed, or published within sixty days before any election, and has a fair market value of one thousand dollars or more per candidate.
- 4.2 **RCW 42.17A.255** states in part that within five days after the date of making an independent expenditure that equals one hundred dollars or more, or within five days after the date of making an independent expenditure, the person who made the independent expenditure shall file a report of all independent expenditures made during the campaign prior to and including such date.
- 4.3 **RCW 42.17A.260** states in part that "the sponsor of political advertising who, within twenty-one days of an election, publishes, mails, or otherwise presents to the public political advertising supporting or opposing a candidate or ballot proposition that qualifies as an independent expenditure with a fair market value of one thousand dollars or more shall deliver, either electronically or in written form, a special report to the commission within twenty-four hours of, or on the first working day after, the date the political advertising is first published, mailed, or otherwise presented to the public."
- 4.4 **RCW 42.17A.305** requires that the sponsor of an electioneering communication shall report to the commission within twenty-four hours of, or on the first working day after, the date the electioneering communication is broadcast, transmitted, mailed, erected, distributed, or otherwise published, and include: (a) Name and address of the sponsor; (b) Source of funds for the communication, (c) Name and address of the person to whom an electioneering communication related expenditure was made; (d) A detailed description of each expenditure of more than one hundred dollars; (e) The date the expenditure was made and the date the electioneering communication was first broadcast, transmitted, mailed, erected, distributed, or otherwise published; (f) The amount of the expenditure; and (g) The name of each candidate clearly identified in the electioneering communication, the office being sought by each candidate, and the amount of the expenditure attributable to each candidate.
- 4.5 **RCW 42.17A.235 and 240** require continuing political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report. C-4 reports are also required 21 and 7 days before each election in which the committee makes expenditures, and in the month following the election.

The C-4 reports are required to accurately disclose contribution and expenditure information, including the name and address of each person to whom an expenditure was made, the amount, date, and description or purpose of each expenditure, and the total sum of all expenditures.

To Whom It May Concern:

Please accept this letter as a formal complaint to the Public Disclosure Commission concerning the North Cascade Jobs Enterprise Washington's disregard of public disclosure law, particularly not properly filing C6 reports for paid website domains and television time.

According to RCW 42.17A.260(1), the sponsor of political advertising who presents to the public political advertising that qualifies as an independent expenditure shall *deliver a special report to the commission within twenty-four hours of the date the political advertising is first published, mailed, or otherwise presented to the public*. North Cascade Jobs Enterprise Washington has not filed a single C6 report for neither the purchased television time or the website [www.seattlevargas.com](http://www.seattlevargas.com). This shows a trend of public disclosure law violations that need to be addressed.

The website, [www.seattlevargas.com](http://www.seattlevargas.com), indicates at the bottom of the page that is paid for by North Cascade Jobs Enterprise Washington. According to a website domain look-up (<https://whois.icann.org/en/lookup?name=www.seattlevargas.com>), the website was purchased on October 9, 2018. Since no C6 has been filed for this website, North Cascade Jobs Enterprise Washington is in violation of RCW 42.17A.260(1), as they have passed the twenty-four-hour deadline.

The organization also purchased television time, which is evident in the attached FCC file. Advertisements were shown in Whatcom County as early as October 11, 2018. There are no filed C6s for the purchased cable advertisements sold by Medium Buying LLC. This makes North Cascade Jobs Enterprise Washington in violation of RCW 42.17A.260(1) on two separate accounts.

I respectfully request an investigation into this unlawful conduct by the North Cascade Jobs Enterprise be issued immediately.

As you are aware, North Cascade Jobs Enterprise Washington (NCJ) indicated early this month its intent to gather data and immediately amend or file reports as required to address PDC Case No. 42387. Unfortunately, significant technical difficulties in filing were encountered almost immediately, and despite extensive work with PDC staff, were not resolved until last week when PDC technical staff on January 16, 2019 finally suggested that NCJ create a new account and refile reports.

On January 18, 2019, C-6 #9040 was filed which addresses the concerns raised in this case. NCJ regrets the oversight in not disclosing this advertising previously. Please note that the website cited in the case was presented to the public on October 10, 2019 in concurrence with the TV advertising.
