The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on Oct. 20, 2018. Your complaint alleged the Snohomish County Democratic Party may have violated (1) RCW 42.17A.220 for accepting over-limit anonymous contributions (2) RCW 42.17A.240 for failing to accurately file contribution reports and (3) RCW 42.17A.235 for failing to timely report expenditures for the Blue Wave Gala.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the allegations contained in the complaint are substantially similar to PDC complaint 40870, resolved Dec. 4, 2018.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1) and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
