I SHIR REGEV, hereby acknowledge that I:

- Exceeded the \$5,000 contribution limitations of the Mini Reporting option on July 19, 2018, in violation of WAC 390-16-125, when I made a \$1,571 in-kind contribution using my personal funds to pay for and distribute a mailer in support of my candidacy.

In addition, I further acknowledge that I failed to:


- Timely file an amended Candidate Registration (C-1 report) for my 2018 campaign for election to the office of State Representative in the 8<sup>th</sup> Legislative District, changing my filing status as a candidate from the Mini Reporting Option to the Full Reporting option, in violation of RCW 42.17A.205.
- Timely file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports) for my 2018 campaign for election to the office of State Representative in the 8<sup>th</sup> Legislative District as required for a candidate required to be under the Full Reporting option, in violation of RCW 42.17A.235 and .240.

Shir Regev would like to avoid the time and expense resulting from a Brief Adjudicative Proceeding being scheduled by Public Disclosure Commission (PDC) staff. Therefore, in lieu of PDC staff scheduling a Hearing, I am completing this Statement of Understanding, and enclosing a check or money order in the amount of \$300 as a penalty payment to resolve this matter as a candidate for public office in 2018.

The \$300 penalty being assessed, includes a \$150 penalty in accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143, for each of the following acknowledged violations:

1. RCW 42.17A.205 for failing to timely file an amended C-1 report changing to the Full Reporting option.
2. RCW 42.17A.235 and .240 for failing to timely file C-3 reports disclosing monetary contributions received, and C-4 reports disclosing contribution and expenditure activities.

I understand that by completing this Statement of Understanding, I am acknowledging the violations of Chapter 42.17A RCW and Title 390 WAC set forth above, and I am waiving my right to a hearing in this matter. I further understand that this will resolve the issue of my exceeding the Mini Reporting option for the 2018 election cycle.
