There is no information I.e., an amended C1 or other filing, that shows a change in party affiliation.

Additional Violation of RCW 42.17A.320

RCW 42.17A.320(1):

"For partisan office, if a candidate has expressed a party or independent preference on the declaration of candidacy, that party or independent designation shall be clearly identified in electioneering communications, independent expenditures, or political advertising."

Candidate's C1 dated 9/11/18 shows Party Affiliation as "Republican."
Candidate's Mailer displayed on 10/05/18 shows "Non Partisan."

Please amend my Complaint 42716 to include the following:

Violation of RCW 42.17A and PDC Regulations, specifically the \$500.00 single contribution limit for Mini-Filers.

The mailer was clearly a contribution and was recognized as such.

Ms. Beach acknowledges the mailer and thanks the donors.

October 5, 2018: “Pend Oreille County will be receiving this beautiful piece of artwork in their mailboxes.” and “Thank everyone for making this beautiful flyer happen.”

The mailer clearly exceeds the \$500.00 contribution limit for a Mini-Filer.

Mr. Maesner’s comments on Social Media speak to the scope of the mailing.

October 5, 2018: “Has anyone in Pend Oreille County checked their mailbox yet? There’s a surprise coming for you, everybody’s getting one.”

October 14, 2018: “If you live in Pend Oreille County and have not received this mailer pictured below I would like to know your street address.”

October 16, 2018: “...one postal carrier was a hundred short...”

Another candidate in Pend Oreille County, who elected Full Reporting, spent \$2,603.77 for similar mailers directed at the same voting demographic. Note postage and postmark on attached files.


It is extremely unlikely that Ms. Beach’s mailer could have been created, printed, and mailed for less than \$500.00.



