On Sunday July 29, 2018 in Ione Park, Sgt Glenn Blakeslee was in his County supplied sheriff's uniform with a County Sheriff's cruiser passing out Blakeslee for Sheriff campaign signs out of the back of his Sheriff's cruiser at Ione's Down River Days. Multiple county residence saw this violation of campaign law while using County supplied equipment i.e. uniform, duty belt, vehicle.

What impact does the alleged violation(s) have on the public?

Implies that the Sheriff's Office is supporting one candidate over another.

Appears to be using County funds for his personal campaign, i.e. same as stealing County funds for his campaign,


