Report of Investigation

I.

Background. Complaint and Allegations

- 1.1 The United Food & Commercial Workers (UFCW) 21 PAC is a political committee registered with the Public Disclosure Commission (PDC) and has been filing committee campaign finance reports since July 28, 2009. The UFCW 21 PAC (Committee) is sponsored by and affiliated with the UFCW Local 21.
- 1.2 On March 11, 2016, the Committee filed an amended Committee Registration (C-1pc report) with the PDC as a continuing committee, selecting the Full Reporting Option and listing Todd Crosby as President, Sarah Cherin as Committee Manager, and Faye Guenther as Treasurer. **Exhibit #1.**
- 1.3 On July 18, 2017, the Committee filed an amended C-1pc report with the PDC as a continuing committee under the Full Reporting Option, and listing Mr. Crosby as President and Ms. Guenther as Treasurer, but the only change was to list James To as Committee Manger. **Exhibit #1.**
- 1.4 On March 8, 2018, the Committee filed an amended C-1pc report with the PDC as a continuing committee under the Full Reporting Option, listing Mr. Crosby as President, and changing Ms. Guenther from Treasurer to Committee Manager, and listing Jason Bennett as a non-ministerial Treasurer. **Exhibit #1.**
- 1.5 On October 29, 2018, Glen Morgan filed a complaint with the PDC, alleging that the Committee violated:
 - RCW 42.17A.235 and .240 by failing to file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditures reports (C-4 reports) disclosing contribution and expenditure activities; and

- RCW 42.17A.220 by failing to timely deposit monetary contributions into the committee bank account within five business days of receipt, as required for a political committee registered with the PDC. **Exhibit #2.**

II. **Investigative Findings**

- 2.1 Political committees that selected the Full Reporting option, and participated in the 2017 primary and general elections by either making contributions or independent expenditures to support or oppose candidates or ballot propositions; endorsing candidates or ballot propositions, or making contributions to a political committee, including caucus and caucus-related political committee or political party organizations, were required to file the following reports in calendar year 2017:
- Monetary contributions must be deposited into the committee bank account within five business days of receipt, and the Committee is required to file one C-3 report for each bank deposit.
 - Monthly C-3 reports are due to be filed by the 10th of each month disclosing contributions received and deposited during the previous calendar month.
 - Weekly C-3 reports are filed every Monday beginning June 1 through November 5, 2017, for contributions received and deposited the previous five business days.
 - Monthly C-4 reports are required to be filed for the periods January 1 through May 31, 2017, and December 1 through 31, 2017, and are due by the 10th of the month if \$200 in contributions has been received or \$200 in expenditures have been made since the last C-4 report was filed.
 - A 21-day Pre-Primary Election C-4 report was due on July 11, 2017, covering the period June 1 through July 10, 2017; and a 7-day Pre-Primary Election C-4 report was due on July 25, 2016, covering the period July 11 through July 24, 2016.
 - A Post-Primary Election C-4 report was due by September 10, 2017, covering the period July 25 through August 31, 2017.
 - A 21-day Pre-General Election C-4 report was due on October 17, 2017, covering the period September 1 through October 16, 2017; and a 7-day Pre-General Election C-4 report was due on October 31, 2017, covering the period October 17 through October 30, 2017.
 - A Post-General Election C-4 report was due by December 10, 2017, covering the period October 31 through November 30, 2017.
- 2.2 On February 22, 2017, the Committee filed two C-4 reports which included the 2016 Post-General Election C-4 report disclosing a \$78 in-kind contribution from UFCW Local 21 for staffing and overhead costs of running the PAC.

- 2.3 The Committee also filed the December 2016 C-4 report disclosing a \$104 in-kind contribution from UFCW Local 21 for staff and overhead costs of running the PAC.
- 2.4 The Committee failed to file any C-3 or C-4 reports disclosing contribution and expenditure activities undertaken during calendar year 2107.
- 2.5 On March 12, 2018, the Committee timely filed the February 2018 C-4 report disclosing \$1,062 for in-contributions from the UFCW for the staffing and internal overhead costs to run the political committee.
- 2.6 The Committee timely filed its C-3 and C-4 reports covering the period of February 1 through December 31, 2018.

Failure to timely file C-4 reports:

- 2.7 On August 24, 2018, the Committee filed 12 C-4 reports covering the period January 1, 2017 through December 31, 2017, disclosing \$284,564 for both monetary and in-kind contributions received which included \$22,588 in funds carried forward from December 31, 2016, and \$279,076 in expenditures made.
- 2.8 The \$279,076 in expenditures made by the Committee in 2017, were disclosed between 226 to 501 days late, and included the following monetary and in-kind contributions made to candidates and political committees for the 2017 elections (**Exhibit #3: 2017 C-4 reports filed by the Committee**):
 - \$80,000 for three monetary contributions made to New Directions PAC, a continuing political committee that made contributions to other political committees including the Eastside Leadership Council and Mainstream Voters of Washington. In 2017, New Directions PAC also engaged in research, polling, issue advocacy and other activities related to the 2017 Senate special election in the 45th Legislative District. The Committee contributions included a \$50,000 monetary contribution made on September 19, 2017, and a \$25,000 monetary contribution made on June 13, 2017.
 - \$75,000 for two monetary contributions made to Working Families for Teresa Mosqueda, an independent expenditure political committee registered with the PDC in support of Teresa Mosqueda, a 2017 candidate for Seattle City Council. The Committee contributions included a \$50,000 monetary contribution made on July 17, 2017, and a \$25,000 monetary contribution made on October 13, 2017.
 - \$70,000 for seven monetary contributions made to six other political committees, that included: (1) a \$17,500 monetary contribution to Together for Tacoma; (2) a \$15,000 monetary contribution to One America Votes Justice Fund; (3) a \$15,000 monetary contribution made to Our Vote Counts; (4) a \$10,000 monetary contribution made to Fuse Votes; (5) a \$10,000 monetary contribution made to Political Destiny; and (6) a \$2,500 monetary contribution made to Working Families of Tacoma.

Each of the six political committees participated in the 2017 elections by making contributions, independent expenditures or electioneering communications, and/or producing and distributing a Voter Guide.

- \$44,600 for monetary contributions made to 2017 candidates for local and legislative offices.
- \$8,825 for in-kind contributions made to the Committee for UFCW Local 21 for the staff and overhead costs of running the PAC.

2.9 The \$279,076 in expenditures made by the Committee in 2017 is detailed in the chart below:

Failure to timely file C-3 reports:

- 2.10 The vast majority of the contributions received by the Committee are from UFCW Local 21.
- 2.11 On August 9, 2016, the Committee timely filed a C-3 report disclosing a \$88,500 contribution received from UFCW Local 21 on August 3, 2016 and deposited the contribution on August 5, 2016.
- 2.12 The Committee failed to file any C-3 reports during calendar year 2017 for monetary contributions received and deposited in the committee bank account.
- 2.13 On May 10, 2018, the Committee timely filed a C-3 report disclosing a \$50,000 contribution received from UFCW Local 21 on April 24, 2018 and deposited on the same day.
- 2.14 On August 24, 2018, the Committee filed nine C-3 reports covering the period January 1, 2017 through December 31, 2017, disclosing \$253,210 in monetary contributions received and deposited into the bank account as follows (**Exhibit #4: 2017 C-3 reports filed by the Committee**):

Failure to timely deposit monetary contributions

- 2.15 As noted above, RCW 42.17A.220 requires political committees to deposit monetary contributions into the designated bank account or depository, within five business days of receipt.
- 2.16 Based solely on the deposit dates listed on the C-3 reports and the Schedule A to C-4 reports, the Committee appeared to have timely deposited monetary contributions received during all of calendar year 2017.

Response from the Committee

- 2.17 On December 20, 2018, Jason Bennett with Argo Strategies submitted a letter to the PDC responding to the complaint filed against the Committee. **Exhibit #5.** Mr. Bennett stated that in March of 2018, “Argo Strategies was retained to assist UFCW 21 PAC in conducting a thorough evaluation of not only compliance filings but also the status of their books of account after it was discovered by senior UFCW 21 staff that there was a breakdown in their internal system of compliance reporting for their PAC's 2017 activity.”
- 2.18 Mr. Bennett stated that upon discovering the failure to file C-3 and C-4 reports for calendar year 2017, “UFCW 21 PAC took immediate action, including personnel action, and decided that in order to ensure that there would be no similar compliance errors in the future, the work of compliance would be outsourced to Argo Strategies. Thereafter, collectively, Argo Strategies and UFCW 21 PAC began the process of performing an internal audit and bringing the account into current filing status for the 2018 cycle.” He stated that Argo Strategies:
 - Conducted a desktop audit of the 2018 calendar year and filed the missing 2018 C-3 and C-4 reports to bring the Committee “into current compliance.”
 - Began “the process of piecing together” the 2017 contribution and expenditure activities and reconciled the Online Reporting of Campaign Activities (ORCA) accounts “so that the bank statements and the ORCA file matched to the penny.
 - “Proactively filed each of the required reports in August 2018, two months before Mr. Morgan's complaint. The PAC acted in good faith when it identified an issue and acted promptly to fix the issue as quickly as possible.”
- 2.19 Mr. Bennett stated that the Committee has no prior PDC violations, and “since Argo Strategies was retained in March of 2018, the Committee has timely and accurately filed its C-3 and C-4 report.”

“It is our hope that the Commission will see that this was an isolated incident and recognize that UFCW 21 PAC has worked proactively to bring the PAC into full compliance. Finally, I have appreciated my close working relationship with the PDC and hope that my own efforts to communicate proactively when issues arise and seek guidance from the PDC consistently will be considered as this moves forward.”

III. **Scope**

3.1 PDC staff reviewed the following documents:

- The complaint and exhibits filed on October 29, 2018, by Glen Morgan against UFCW 21 PAC.
- December 13, 2018, in-person meeting in Olympia with PDC staff and Jason Bennett with Argo Strategies, Dmitri Iglitzin, andUFCW 21 PAC Officer.
- Telephone conversations and email communications with Dmitri Iglitzin, on behalf of UFCW 21 PAC.
- C-3 and C-4 reports filed by UFCW 21 PAC covering the period of July 1, 2016 through December 31, 2018.

3.2 Queried the PDC Contribution and Expenditure database for UFCW 21 PAC contribution and expenditure information covering the period of July 1, 2016 through December 31, 2018.

IV. **Statutes and Rules**

4.1 **RCW 42.17A.235 and 240** require continuing political committees to file timely, accurate C-3 and C-4 reports disclosing contribution and expenditure activities undertaken by the committee. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report.

Beginning June 1st for every political committees participating in an election, C-4 reports are required 21 and 7 days before each election in which the committee receives contributions or makes expenditures, and in the month following the election. Monetary contributions are reported weekly during this same time and are required to be disclosed on a C-3 report filed every Monday for monetary contributions deposited into the committee bank account the previous five business days.

4.2 **RCW 42.17A.220** requires continuing political committees to deposit all monetary contributions into the designated bank account or depository, within five business days of receipt.

To Whom it May Concern --

It has come to my attention that the United Food and Commercial Workers – Local 21 PAC (hereafter collectively referred to as “respondent”) has habitually and willfully committed frequent and multiple violations of **RCW 42.17A**. Additionally, I have reason to believe that other violations of this chapter have occurred beyond what I have identified below.

1) Failure to file accurate, timely C3 and C4 reports, failure to timely deposit contributions. (Violation of RCW 42.17A.235, .220)

State law requires that candidates and committees file frequent, accurate, reports of contributions, expenditures, in-kind contributions, debt, pledges, and loans (C3s and C4s). The reports must be compliant with both state law and PDC regulations (**WAC 390**). State law also requires that contributions must be deposited within 5 business days of receipt. Unfortunately, the respondent has failed on numerous occasions to do this, including, but not limited to the late reports detailed in the attached exhibit. Additionally, the respondent has failed to report debt and properly break down/detail expenditures.

Please note, this secretive PAC’s extremely late filings are a total of at least 4,189 days late and involve large sums of hidden cash which was kept from the public during the critical 30 day window through a variety of elections over the past few years, and in many cases these reports were submitted years after the elections were long past. This denied the public or the media any access to the truth about the funding or spending for this well-funded, very sophisticated big-money PAC

above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.

Dear Public Disclosure Commission:

Thank you for the opportunity to respond to the recent complaint (#42719) filed by Mr. Glen Morgan and for the opportunity to discuss this issue with PDC Compliance Officer Kurt Young at our recent December 3rd meeting in Olympia. As requested during the meeting, we are submitting additional information for your consideration.

In March of this year, Argo Strategies was retained to assist UFCW 21 PAC in conducting a thorough evaluation of not only compliance filings but also the status of their books of account after it was discovered by senior UFCW 21 staff that there was a breakdown in their internal system of compliance reporting for their PAC's 2017 activity. Upon discovery, UFCW 21 PAC took immediate action, including personnel action, and decided that in order to ensure that there would be no similar compliance errors in the future, the work of compliance would be outsourced to Argo Strategies. Thereafter, collectively, Argo Strategies and UFCW 21 PAC began the process of performing an internal audit and bringing the account into current filing status for the 2018 cycle.

We first conducted a desktop audit of the current filing period (CY 2018) and brought those accounts into current status. Then, we began the process of piecing together the CY 2017 reporting file and reconciling the accounts so that the bank statements and the ORCA file matched to the penny. After that process was completed, we proactively filed each of the required reports in August 2018, two months before Mr. Morgan's complaint. The PAC acted in good faith when it identified an issue and acted promptly to fix the issue as quickly as possible.

UFCW 21 PAC has not had previous violations with the PDC. Since Argo has been retained, the 2018 PAC reports have been filed timely and accurately as well. It is our hope that the Commission will see that this was an isolated incident and recognize that UFCW 21 PAC has worked proactively to bring the PAC into full compliance. Finally, I have appreciated my close working relationship with the PDC and hope that my own efforts to communicate proactively when issues arise and seek guidance from the PDC consistently will be considered as this moves forward.

We appreciate the willingness of the Public Disclosure Commission to consider these factors when entering into a stipulation agreement with the PAC.
