Subject: Complaint regarding Linda Oosterman; PDC Case 42952

Dear Andrew Saturn:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on November 1, 2018. Your complaint alleged that Linda Oosterman may have violated RCW 42.17A.205 for failure to accurately and completely report committee officers, and RCW 42.17A.240 for failure to report in-kind contributions.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Linda Oosterman filed a C-1 candidate registration listing Treasurer Shawn Myers as the sole officer, performing more than ministerial duties, as required by RCW 42.17A.205.
- No evidence was provided by the complainant to support the allegation that additional officers served on both the candidate's committee and Up for Thurston PAC, thus their expenditures do not appear to constitute in-kind contributions to the Linda Oosterman campaign.

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of an actual violation warranting further investigation.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1), and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
