



At or about 1:46:00 the Moderator, Newport Miner Publisher Michelle Nedved, addresses Ms. Sheryl Miller as "Secretary of CANSS" and asks if Ms. Miller will "be directed by members of CANSS." Ms. Miller replies that "if...elected commissioner I will have to resign my position on the board."

Ms. Miller represents herself as CANSS Secretary, an assertion that is not challenged.




