I believe money is being funneled through the Clark County Democratic party organization to get around campaign finance limits.

PAC 48 donated \$1,000.00 to the Tanisha Harris campaign on September 12, 2018. That maxed out their campaign contribution limits.

On October 9, 2018, PAC 48 donated \$2,000.00 to the Clark County Democrats.

On October 27, 2018, the Clark County Democrats processed the 10/9/18 contribution then donated \$2,000.00 to the Tanisha Harris campaign. There are no record of any votes to have this money expended. It appears PAC 48 funneled the money through the party organization since it could not legally give directly to the candidate. There is no legitimate way any committee of the Clark County Democrats could have made this decision based off our bylaws. How made this decision? Who all knew about it before and after it happened? Are there any records of this decision being made?

On October 29, 2018, PAC 48 donated another \$2,000.00 to the Clark County Democrats. On the same day, the Clark County Democrats donated \$2,000.00 to the Monica Stonier campaign. Again, the voting members of the Clark County Democrats had no vote to expend this money. There's no record of the vote even taking place or who made the decision. This money is not a contribution to the Clark County Democrats to decide how to use. This is money that literally just passes through our party organization to go directly to candidates. This money is not intended for the voting members of the Clark County Democrats to decide how to use. These decisions are being made by unknown individuals without our knowledge or consent. We literally have to see this info on the PDC website to even know it happened! Something is very wrong here.

### What impact does the alleged violation(s) have on the public?

The Elected PCO's of the Clark County Democrats are going to be voting on who will lead their local party organization in 2019 & 2020. Some of the same people who participated or benefited from these secretive transactions are running for party leadership position. They keep saying all of this is legal. It does not look legal. We cannot make informed decisions without the PDC confirming violations.

They can just lie and say "It's not earmarked money" even though it is. Even though it came in and there's no record of any vote to expend this money. members weren't even told this money was being expended. The money came in and went out on the same exact day. There's isn't time to send out meeting notices and hold a vote of any official kind. Who ever made this decision isn't being transparent with the membership.
