Subject: Complaint regarding Senator Kevin Ranker, PDC Case 46332

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on January 28, 2019. Your complaint alleged that Senator Kevin Ranker may have violated RCW 42.17A.700 by failing to accurately and timely report financial interest in a business entity on his Personal Financial Affairs Statement (F-1 report).

PDC staff reviewed your allegations and, as a result of staff's review, found the following:

- The Respondent was (re)elected as a State Senator in 2012 and 2016 and served in this position from 2013 until he resigned from office in early 2019. The Respondent timely filed the required F-1 reports for financial years 2014 - 2017.
- According to the Washington State Office of the Secretary of State, Coast Policy Group, LLC formed on April 9, 2014, reported the Respondent as a "Manager" effective April 21, 2014, and voluntarily dissolved on April 26, 2017.
- The Respondent failed to report financial interest in Coast Policy Group, LLC on his F-1 reports containing financial data for years 2014 - 2017.
- The Respondent indicated that Coast Policy Group, LLC was formed with the intention of providing environmental consulting services but never became active. The LLC did not have any clients, receive any income or provide any services. The Respondent forgot to report the LLC on his F-1 reports due to its inactivity.
- The Respondent has one prior violation concerning PDC requirements that are unrelated to the subject of this complaint (PDC Case 12710).

Based on these findings, staff has determined that, in this instance, failure to report financial interest in Coast Policy Group, LLC on F-1 reports for 2014 - 2017 does not amount to an actual violation warranting further investigation.

PDC staff is reminding Senator Kevin Ranker about the importance of accurately disclosing all business interests and offices held on his Personal Financial Affairs Statement (F-1 report).

Senator Kevin Ranker made minor or ministerial errors on required reports, which did not materially impact the public interest. Upon notification of these errors, Senator Kevin Ranker amended his reports, making the necessary technical corrections.

The PDC has dismissed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
