Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Daniel Strauss, a registered lobbyist for Alliance for Gun Responsibility may have violated RCW 42.17A.605 for failure to provide a recent photograph at the time of lobbyist registration.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by Daniel Strauss; the applicable PDC reports filed by Respondent; and the revisions screen of the electronic lobbyist application, to determine whether the record supports a finding of one or more violations.

Based on staff’s review, we found the following:

- Daniel Strauss first registered in the electronic lobbyist application as a lobbyist agent for the Alliance for Gun Responsibility on July 1, 2016, and failed to provide a recent photograph as required by RCW 42.17A.605.
- On March 27, 2019, Daniel Strauss uploaded a recent photograph to the biograph page of the electronic lobbyist application.

Based on these findings staff has determined that, in this instance, failure to provide a recent photograph at the time of lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Daniel Strauss about the importance of providing a recent photograph at the time of lobbyist registration. PDC staff expects that you will provide a recent photograph at the time of any future lobbyist registrations.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
