Subject: Complaint regarding Glen Morgan, PDC Case 46466

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Cody Arledge, a registered lobbyist, may have violated RCW 42.17A.605 for failure to provide a recent photograph at the time of lobbyist registration.

PDC staff reviewed the allegations; the applicable statutes, rules, and reporting requirements; the and queried the Respondent’s revision history in the electronic lobbyist application, to determine whether the record supports a finding of one or more violations.

Based on staff’s review, we found the following:

- Cody Arledge is a registered lobbyist associated with three lobbyist firms: Cody Arledge, Johnson Arledge Strategies, and Arledge Group.
- Johnson Arledge Strategies first registered as a lobbyist firm in the electronic lobbyist application on July 1, 2016, and failed to provide a recent photograph of Cody Arledge at the time of registration as required by RCW 42.17A.605.
- Cody Arledge provided a recent photograph for the registration at Johnson Arledge Strategies on March 15, 2019.
- Cody Arledge registered as a sole individual serving as a lobbyist firm on July 1, 2016, and failed to provide a recent photograph at the time of registration as required by RCW 42.17A.605.
- Cody Arledge provided a recent photograph for the registration under Cody Arledge as an individual lobbyist on March 15, 2019.
- Arledge Group first registered as a lobbyist firm on November 11, 2017, and failed to provide a recent photograph of Cody Arledge at the time of lobbyist registration as required by RCW 42.17A.605.
- Cody Arledge provided a recent photograph for the registration under Arledge Group on November 30, 2018.

Based on our findings staff has determined that, in this instance, failure to provide a recent photograph at the time of lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Cody Arledge about the importance of providing a recent photograph for the lobbyist biography. In the future, staff expects that this photograph will be provided at the time of any future registrations.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
