Subject: Complaint regarding Darcy Nonemacher, PDC Case 46642

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Darcy Nonemacher may have violated RCW 42.17A.605 by failing to submit a recent photograph for her lobbyist registration.

PDC staff reviewed your allegations and, as a result of staff's review, we found the following:

- Darcy Nonemacher (the "Respondent") is a registered lobbyist, employed by WA Environmental Council, who failed to submit a recent photograph to the PDC as required per RCW 42.17A.605.
- The Respondent took corrective action and uploaded the missing photograph on March 8, 2019. A prior unsuccessful attempt to upload the photo was also made on February 27, 2019.
- The Respondent missed the PDC's original email notice of February 6, 2019 but responded to our February 27, 2019 follow up query within 24 hours.
- The Respondent indicated she submitted a hard copy version of her lobbyist photo in the past and erroneously believed it sufficed for online registration.

Based on these findings, staff has determined that in this instance, failure to submit a photograph for a lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Darcy Nonemacher about the importance of submitting a recent photograph when registering as a lobbyist, and the timely filing of all future required lobbyist registration information.

The PDC has dismissed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
