Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Paula Swedeen may have violated RCW 42.17A.605 by failing to submit a recent photograph for her lobbyist registration.

PDC staff reviewed your allegations, and as a result of staff's review, we found the following:

- Paula Swedeen (the "Respondent") is a registered lobbyist, employed by Conservation NW, who failed to submit a recent photograph to the PDC as required per RCW 42.17A.605.
- The Respondent took corrective action within 24 hours of being notified by the PDC and uploaded the missing photograph on February 6, 2019.
- The Respondent indicated that the omission of her photograph was an unintentional oversight, which was quickly remedied.

Based on these findings, staff has determined that in this instance, failure to submit a photograph for a lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Paula Swedeen about the importance of submitting a recent photograph when registering as a lobbyist, and the timely filing of all future required lobbyist registration information.

The PDC has dismissed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
